

**PROCEEDINGS OF THE DISTRICT DEVELOPMENT CO-ORDINATION &  
MONITORING COMMITTEE MEETING (DISHA)**

**HELD ON DT 9.11.2017**

The DISHA meeting was held on 9<sup>th</sup> November 2017 under the Chairmanship of S.J. Tathagata Satapathy, Hon'ble MP, Dhenkanal in the Conference Hall of DRDA, Angul.

At the outset the Hon'ble Chairman welcomed all the members and participants of the meeting. The DIO, NIC, Angul has been advised to upload the proceedings and action taken report of the DISHA meeting in the District website regularly. Hon'ble MLA, Angul stated that all should strive hard for successful implementation of all Govt. schemes and to make them people centric.

**1. CONFIRMATION OF PREVIOUS PROCEEDING :**

The action taken report of the last DISHA meeting held on 25<sup>th</sup> August, 2016 was read out by PD, DRDA and it is confirmed by the Committee as no objection has been received from any quarter.

**2. NOMINATION OF MEMBERS**

As per guideline of DISHA 5 nos of Sarpanchs need to be nominated; for which it is decided that each MLA would suggest one such name from their Assembly Constituency area. Similarly it is decided that one ST member to be nominated would be from the PBDA area as suggested by the Spl. Officer PBDA.

**3. DRINKING WATER AND SANITATION**

While reviewing water supply schemes, EE, RWS & S stated that out of the total 20 nos of overhead tanks of the FY 2016-17, 16 has been completed & rest are under progress which will be completed soon.

Hon'ble Chairman instructed EE, RWS & S to complete all the ongoing drinking water projects in time.

Hon'ble Chairman as well as Hon'ble M.L.A Angul stated that, there is drinking water problem in village Bantala under Angul Block. In reply, EE, RWS & S, Talcher stated that they are trying to find out the water source. As drinking water problem persists Hon'ble MLA, Angul & Hon'ble MLA, Talcher urged upon procurement of sound testing machine out of the DMF fund for locating water source. The proposal was approved in the Committee.

Under SBM, Rs 50.00 Lakh has been released to each blocks as stated by EE,RWS & S . The PFMS has been implemented in 4 blocks namely Athmallik, Chhendipada, Kaniha and Kishorenagar for online transfer of fund to the beneficiaries/ Agency. Collector, Angul directed the other B.D.Os to follow this practice soon.

It was also discussed in the meeting that since in the interior area, the repair and maintenance of Tube-wells are not done properly, in time, people faces problem. EE, RWS & S, was instructed to take special care in this regard.

#### **4. MGNREGS**

While discussing MGNREGS, Hon'ble MLA, Angul stated that there is irregularity in plantation work taken up under MGNREGS. It was decided that Collector, Angul shall form one committee under the Chairmanship of PD DRDA, Angul and the committee will visit the plantation works of last 3 years and submit report in the next meeting & appraise about the findings of the visit.

***Action:PD,DRDA /Line Deptt.s***

#### **5. RURAL HOUSING**

While discussing progress of PMAY-G, Collector, Angul stated that there it online problem and the Awaassoft Software is running very slow for which the registration and sanction process becomes slow. On the issue of selection of house site by the beneficiaries it is apprised that the housing site once selected cannot be changed by the beneficiary under PMAY-G otherwise it will create problem during geo- tagging.

**6. NRLM**

While discussing NRLM activities some Block Chairpersons complained about the irregularity in SHG grading, hence it was decided that all CDPOs, shall attend the DISHA meeting henceforth.

**7. WATER SHED PROGRAMME**

The PD, Watershed, Angul informed that IWMP scheme has been closed and in its place PMKSY has been introduced. He stated that the watershed is functioning independently and the project list are being prepared of its own. After listening to him the committee insisted that the list is to be submitted to the Hon'ble Chairman and to the house in the next meeting and while preparing such scheme the views of the local MLAs, MPs and PRI members should be incorporated.

**8. HEALTH & FAMILY WELFARE**

While discussing health schemes all block Chairpersons complained that officials of Health Department are not attending the block level meetings. Collector Angul instructed CDMO accordingly to ensure attendance, henceforth.

**9. CESU, ELECTRIFICATION**

While discussing electricity issues Hon'ble Chairman asked about the progress of internal cabling in Angul town. In this regard EE, CESU, Angul stated that proposal was there, but due to escalation in estimated cost the proposal was not accepted; however the revised proposal has been submitted again. He informed that internal cabling system will be preferred everywhere to prevent theft.

**10. INTERNET CONNECTIVITY, BSNL**

Collector, Angul stated that internet connectivity in Angul District is very poor. Hon'ble Chairman urged that internet connectivity and the speed must improve. Collector instructed BSNL official accordingly. The BSNL official present in the meeting assured that by end of March 2019, entire district will be covered through speedy internet connectivity.

*Action: GM BSNL, Dhenkanal*


**11. OTHER**




