The interested parties may submit their Quotations / Willingness on or before 09.08.2018 up to 1.30 P.M along with the EMD in shape of Bank Draft payable in favour of BDO, Angul. In case of unsuccessful Bidder the EMD will be refunded. Quotations shall be opened by a Committee consisting of the BDO, Accounts Officer, Asst. Engineer and WEO on the same day at 3.00 PM in presence of the Quotationers or their authorised representatives.

Terms & Conditions:

- ❖ Selected Contractors shall construct 11 KV OH lines, 3p4w LT line & S/S as per the provision in the estimate prepared by CESU.
- ❖ It shall be the Contractor's responsibility to supply all materials at his own cost & arrangements at the above locations ensuring standard specifications & complying to I.E. Rule.

- ❖ **The Transformers should be Three Star Rated from reputed CPRI approved manufacturer with facility for sealing at LT Bushing side. The guarantee period of Transformer shall be minimum for 2 years from the date of commissioning.**
- ❖ Contractor shall intimate the CESU Engineer (Manager, Electrical) E & MR Division, Dhenkanal well in advance regarding the manufacturers address to test the transformers at factory before installation at project premises & they should certify that, the transformer is a three star rated as per Circular No 39455 Dt. 18.08.10 of C.O.O, CESU, BBSR which should be arranged by the Contractor, positively.
- ❖ The Transformers should be star rated with minimum level of "No Load Losses" as specified by BEE. The manufacture should be advised accordingly to produce the certificate from BEE.
- ❖ Suitable shunt capacitor is to be provided by the Contractor to improve power factor.
- ❖ The CESU empanelled HT Electrical Contractors are requested to submit the attested copies of up-to-date valid GSTN/PAN/HT Electrical License, Empanelment Order, Bank details etc along with their Quotations / willingness failing which their quotations shall be rejected.
- ❖ **Before execution of work, the Contractor must have to submit the type test report of materials to be used at site followed by inspection of materials as per CESU Specification as per letter no. 33572 Dt. 11.12.2013 of COO, CESU, BBSR.**
- ❖ Prior to taking of work, the concerned SDO (Electrical) and Jr. Manager (Electrical) are to be intimated for finalization of route alignment work.
- ❖ The metering will be done individually as per CESU rules.
- ❖ Any dispute / legal complicacy arising out of damage / accident owing to construction of 11KV line, and S/S has to be settled by the party.
- ❖ All safety aspects are to be ensured for construction of line & S/S.
- ❖ The road crossing guarding is to be provided under 11 KV line if required.
- ❖ The 11 KV line and other equipments after due inspection by Electrical Inspector, Govt. of Odisha and testing etc as required shall be taken over by site engineer, item wise from the consumer, specifically with due certification by concerned SDO. That
 - (a) No CESU materials have been used in the said construction work.
 - (b) The completed works confirm to approved specification standard sanctioned estimate and other conditions spelt out in CESU letter.
- ❖ The Contractor is requested to arrange for inspection of the 11KV lines, LT line & S/S along with the associate accessories and internal installation by Manager (Elect.) CESU, Angul Electrical Division at your own arrangement.
- ❖ The BDO, Angul shall deposit the 6% supervision charges and 1% Cess amount with CESU and the selected party shall deposit the security amount and 3ph service connection charges in shape of cash/ DD to be drawn in favour of "Manager (Electrical) payable at Angul.
- ❖ The authority reserves the right to cancel any or all quotations without assigning any reason thereof.
