





- The Notices and Terms and conditions and Specification & Prototype of the items to for **WALL PAINTING AT G.P LEVEL ON IYCF** can be obtained from the Office of DSWO, Angul on payment of Rs.2000/- (Rupees Two Thousand ) only ( Non refundable) during the Office hours on any working day till **26.09.2018 by 1.00 PM.**
- The tender papers containing detailed terms and conditions, EMD , other Statutory requirement and sample copy Specification & Prototype of the **WALL PAINTING AT G.P LEVEL ON IYCF** can also be downloaded from the district website [www.angul.nic.in](http://www.angul.nic.in). And while submitting such tender papers a DD of Rs.2000/- (Rupees Two thousand) only in favour of DSWO, Angul payable at Angul is to be submitted failing which the tender paper will be rejected.

- The Tender will be in two parts i.e. Technical Bid (Part-I) and Financial Bid- (Part-I) the Bidders should submit their Technical Bid and Financial Bid separately in two envelop and both the envelop should be kept in a big envelop super scribed for printing of "**WALL PAINTING AT G.P LEVEL ON IYCF**".
- **Bidders who qualify Technical Bid will be eligible to participate in Financial Bid.**
- The successful bidder will have to execute the work of wall painting in 209 GP area of Angul District basing on the indent placed by DSWO, Angul.
- The successful bidder will have to deposit Security Deposit in shape of fixed deposit in favour of DSWO Angul at any Nationalized Bank for an amount of five percent of value of the contract.

7	The tender must be accompanied with Earnest Money of <b>Rs.10, 000/- (Rupees Ten Thousand) only</b> in shape of Demand Draft pledged in favour of Collector, Angul. Tenders without Earnest Money will be liable for rejection. The EMD of unsuccessful bidder will be returned without interest on finalization of bid.
