

**PROCEEDING OF THE MEETING FOR OPENING OF BID
DOCUMENTS INVITED THROUGH REQUEST FOR PROPOSAL (RFP) FOR
SET – UP AND RUNNING OF MOBILE HEALTH UNIT (MHU) ON PPP
MODE UNDER DISTRICT MINERAL FOUNDATION IN ANGUL DISTRICT.**

As per Request for Proposal (RFP) for Set – up and Running of Mobile Health Unit, a meeting was held on 7th August 2018 at 11.30 A.M. in the DRDA Conference Hall, Angul for opening of Bid Documents. Following members of selection committee were present in the meeting, constituted under the Chairmanship of Collector, Angul for opening and evaluation of RFP documents for selection of agency.

At the outset, Project Director, DRDA, Angul welcomed all the committee members & bidders and instructed to open the bid documents which were received within the prescribed cut-off date.

As per the records of District Mineral Foundation, Angul four nos. of agencies as detailed below have applied for the project:

1. Community Action Through Motivation Programme (CAMP), Bhopal, Madhya Pradesh , PIN – 462042.
2. Piramal Swasthya Management and Research Institute, Hyderabad, Telengana , PIN – 500073.
3. Hindustan Latex Family Planning Promotion Trust, Noida, Uttar Pradesh, PIN – 201307.
4. R.K.HIV Aids Research & Care Centre, Bahula, P.Bardhaman, West Bengal, PIN – 713322.

Out of four, the bid document of R.K.HIV Aids Research & Care Centre has been received after cut-off date, so it has been decided not to open the documents of said agency. The bid documents of remaining 03 nos. of agency have been opened for scrutiny of prequalification criteria as per RFP vide no. – 332 dated 17.05.2018. The comparative statement of pre – qualification criteria has been annexed at **Annexure - I**. It is found from the comparative statement that, all the three agencies are qualified for next stage of bid evaluation process.



Hence, the committee allowed Community Action Through Motivation Programme (CAMP), Piramal Swasthya Management and Research Institute, Hindustan Latex Family Planning Promotion Trust to participate in the technical evaluation process.

During the technical bid evaluation process, the documents submitted by bidders were verified in pursuance to the terms and conditions of the RFP. For clause no. 11.1 and point no. – 5 of RFP, the committee decided to award 5 (five) marks each to CAMP , Bhopal and Hindustan Latex FPPT , Noida respectively towards Govt. Recognition and 10 (ten) marks to Piramal Swasthya Management and Research Institute for both Govt. Certificate and Recognition.

Details of scoring by each bidders in Technical Bid Evaluation process are annexed at **Annexure – II**. However, the total score awarded to each agency towards Technical Bid Evaluation is given below:

As all three agencies have been scored more than 60 % of total marks in technical bid evaluation process, all the three bidders are found eligible to participate in Financial Bid.

For opening of Financial Bid documents, a meeting of Committee Members and Bidders was called on 13th August 2018. Accordingly the financial bid document were opened and score are evaluated on **Quality and Cost Based Selection (QCBS) method**. The total score of all three firms in both technical and financial bid have been computed as follows:

As per the above table, the agency **Community Action Through Motivation Programme (CAMP), Bhopal, Madhya Pradesh** has obtained the highest score in QCBS method. Hence, the committee decided to select CAMP, Bhopal for undertaking the assignment / project.

Further, it has been unanimously decided to invite **CAMP, Bhopal** for executing contract for undertaking the project - "Running of Mobile Health Unit (MHU)" in Chhendipada, Talcher & Kaniha Block.
