Background

State Youth Welfare Board (SYWB), Government of Odisha, having its office at Kalinga Stadium, Bhubaneswar, Odisha - 751012, is the Nodal Agency for implementation of the sub scheme Biju Yuva Vahini. Under the Biju Yuva Vahini sub-scheme, an indicative list of sports equipment and its quantity has been approved for procurement for each Biju Yuva Vahini.

Project Director, DRDA Angul intends to procure sports equipment as per the indicative list for 246 (Two hundred forty six) no. of BYVs in Angul District. The detail list of equipment required for each BYV will be given to the successful Bidder after the completion of the tender process. The cost is inclusive of all applicable taxes, transportation cost and a kit box (all the sports equipment to be kept in a box except like Carrom Board, Kho-Kho Post etc., specification of kit box provided along with the indicative list) with printing of BYV logo on it. The upper price limit for each of the sports equipment must be within the price limit mentioned in the indicative list for each items, (inclusive of all charges etc.)

Scope of Work

The bidders are required to submit sample of each sports equipment as per the specification in the indicative list given. Bidders are required to submit the sample of the sports equipment along with price quotation for each of the submitted sample.

The selected bidder is required to make delivery at all Block headquarter (BDO Office) 08 (Eight) nos of blocks of Angul district (Angul, Athamallik, Banarpal, Chhendipada, Kaniha, Kishorenagar, Pallahara, Talcher) within 20days of assignment of the Order/Contract.

General Terms & Conditions:

- All the documents must be self-attested by the Bidder.
- The price quoted should be per unit of items to be supplied at the Block Headquarters including transportation cost, loading/unloading cost & taxes as applicable.
- The agency/supplier will be considered strictly on the basis of the quality of the sample of Sports equipment submitted by the bidders which will be evaluated by a committee to be constituted by District Committee for Biju Yuva Vahini of Angul District.
- Only the technically qualified bidders will be allowed to participate in the financial bid process.

- The committee reserves the right to split the order of supply among multiple bidders based on the requirements.
- Further the authority reserves the right to accept/ reject any / all the bids partially/ fully without assigning any reason thereof.

Other terms & Conditions:

- In no case the brands specified can be changed or compromised.
- It is the responsibility of the supplier to supply the items within stipulated time and in proper condition to the Concerned Block Store room including transportation, loading & unloading.
- Any damage caused due to transportation/ mishandling of items during loading & unloading which has to be done by the supplier will not be borne by the undersigned.
- The authority reserves the right to verify the items supplied with the sample supplied by the bidder with the bids. If the items supplied are found to be lower or below the expected quality, the authority reserves the right to reject the consignment partially/ fully without assigning any reason thereof.

Financial Bids

The Financial bids of only the Bidders whose samples are selected by the Evaluation Committee (Technical) will be opened. Financial Bid must be submitted as per the format at Annexure D.

Contract shall be awarded to the firm(s) offering the lowest/net bundled price and not with reference to lowest prices quoted for the sub-items. However, if prices for each and every item are not quoted, net-bundled price offered shall not be accepted. Further the right to take decision in this regard is reserves with the undersigned & the procurement committee constituted at District Level.

Earnest Money Deposit

As part of its Technical bid submission, the bidder would be required to submit an Earnest Money Deposit amounting to INR Five Lakh (INR 5,00,000/-) in form of a Minimum 2 years Fixed Deposit/ Term Deposit from any Nationalized/ Scheduled Bank duly pledged in favour of Project Director, DRDA, Angul. The EMD of unsuccessful Bidders will be returned to them within two weeks of the selection of successful Bidder with necessary pledge release certificate. For successful bidder, the EMD will be returned upon signing of the contract and submission of Performance Security in the form of Bank Guarantee for a value equal to 10% of the



total contract value. The said Performance Security shall be valid beyond 60 days after the end of all contractual obligations on the part of the supplier including warranty obligations, if any. Any bid submitted without EMD will be rightly rejected. The Earnest Money will be forfeited because of one or more of the following reasons:

- The Bidder withdraws its Bid during the validity period as specified in Bid
- The Bidder does not respond to requests for clarification of its Bid
- The Bidder fails to provide the required information during the evaluation process or is found to be non-responsive or has submitted false information in support of its qualification.
- In case of a Selected Bidder, the said Bidder fails to sign the Agreement in time; or does not furnish the mandatory Performance Security.
- The Bidder materially alters his Bid during the Bid processing period.

Bid Processing Fee

As part of its Technical Bid submission, the bidder would be required to submit a Bid Processing Fee amounting to **Rupees Ten Thousand (Rs 10,000/-)** only in shape of a demand draft made in favour of "**Project Director, DRDA, Angul**" from any nationalized/ scheduled bank payable at Angul. The Bid Processing Fee is **Non Refundable**.

Delivery Mechanism

The delivery of the sports equipment in a box (with lock and key) as per the list of each BYV shall be made by Bidder at the respective Block headquarters. A random quality and quantity check will be conducted at the time of each delivery. If the quantity and quality is found to be non-satisfactory, Bidder will be subjected to a penalty of up to 100% of the order value.
