- 1. The bidder/ lease holder should offer minimum lease value of Rs 100/Sq.mt of cage per
- 2. The lease shall be offered for a period of 5 years & it may be extended upon approval by

The bidder will submit an EMD of Rs 10,000/- in shape of Demand Draft (D.D) in favour of "The Deputy Director of Fisheries, Angul Zone, O/O the DDF (Angul Zone), Near- B.E.D College, Angul, Pin-759122" & it will be adjusted against the lease value after successful completion of EOI as per prevailing rules for returning the EMD of the Govt.
 - 4. Terms & conditions of lease will be as per Govt. rules & regulations & shall be binding on
 - 5. At the time of completion of lease period of lease holder, he/she should handover the cages along with net & other related materials in usable condition.
 - 6. Technical & financial bids are given in annexure-I & II.
 - 7. The entrepreneur has to sign a lease agreement with the DDF (AZ), Angul. Copy of lease
 - 8. Local PFCS shall be given 1st preference, entrepreneurs inside state as 2nd preference & entrepreneur outside state as 3rd preference during selection of entrepreneurs.
 - 9. There will be no performance security in case of PFCS where as private entrepreneurs have to deposit 10% performance security for taking of lease of cages for 5 years.
 - 10. The DDF (AZ), Angul reserves the right to cancel any or all EOI without assigning any reason thereof.
