INVITATION TENDER FROM AUTHORIZATION DEALER FOR SUPPLY OF FOOD GRAIN TO THE STUDENTS OF CLASS IX & X OF 03 BLOCKS CHHENDIPADA, KANIHA & TALCHER UNDER DISTRICT MINERAL FOUNDATION, ANGUL.

Sealed tenders in the prescribed form are invited from the intending registered millers for undertaking for supply of rice to the students of class IX & X in 03 blocks i.e Chhendipada, Kaniha & Talcher of from District Mineral Foundation, Angul under MDM programme Angul district for the year 2018-19 (Nov 18 to Oct 19). The approximate quantity of food stuff to be handled in a year and approximate value of the foodstuff in the govt. rate are as follows :

Approximate Qtl of foodstuff in Qtl. **7200 Qtl @ 28.23 per KG as per Govt. rate**

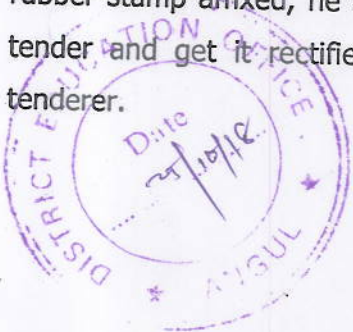
Approximate value of the foodstuff = **7200 qtl X 28.23 = 20325600**

The tender shall be received by the District Project Management Unit (DPMU), Mid Day Meal (MDM), Angul on behalf of Collector, Angul till 1.0 PM PM on dt 16/11/18 by registered post and will be opened on the same day at 04.00 PM in the office chamber of Collector, Angul in the presence of Tender Committee members and tenderer or their authorized representative by producing the letter of authorization. The tender received beyond the date and time shall be liable for rejection.

The tender papers should be submitted sealed cover super scribing in Block Capital Letters, such as "TENDER FOR UNDERTAKING SUPPLY OF FOOD GRAIN FOR THE STUDENTS OF CLASS IX & X FROM DISTRICT MINERAL FOUNDATION, ANGUL UNDER MDM PROGRAMME IN THREE BLOCKS I.E CHHENDIPADA, KANIHA & TALCHER IN ANGUL DISTRICT.

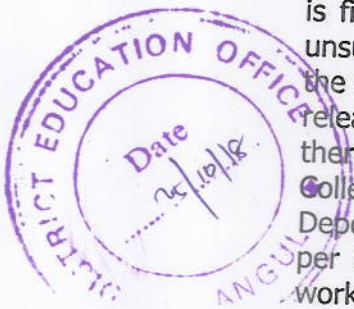
The detailed tender paper along with prescribed tender schedule can be purchased / obtained from the office of the District Project Management Unit (DPMU), Mid Day Meal Angul on payment of Rs 5000/- (Non refundable) on any working day during office hours from dt 26/10/18 to dt 16/11/18 till 01.00 PM and money receipt obtained in token of purchase of tender paper in original shall be submitted along with the tender form. The tender without original money receipt will be summarily rejected. The detailed tender paper should be returned with the tender duly signed by the tenderer as token of acceptance of the terms and conditions.

Each set of tender documents shall be serially numbered and each page there of duly authenticate by initial / signature of any office authorized by the Collector, Angul and rubber stamp affixed. The tenderer should check up tender documents immediately after purchase of the same. If the set purchased by the tenderer does not obtain the initial / signature and rubber stamp affixed, he should immediately report the fact to the officer who has issued the tender and get it rectified. All the tender papers / documents are to be attested by the tenderer.




TERMS AND CONDITIONS OF THE TENDER

- 1 The Tenderer shall carefully go through all the terms and conditions of the tender documents and submit the tender papers correctly and in complete form. The tender paper should be filled properly and legibly without any correction / overwriting and must be a typed copy / computer type copy. No opportunity shall be given to the tenderer to rectify or amend and defect detected at time of scrutiny. The rates should be written both in words and figures in the tender. The rate quoted should be final and the tenderer shall not be allowed to change the same under any circumstances and it should be changed time to time after receipt of instruction from Govt.
- 2 "No individual, company, firm, corporation shall participate in the tender process unless it obtain or process valid miller license under Rice milling Industry Act.
- 3 It is the responsibility of the tenderer shall delivery the food grain in proper weightment. The transport agent will deliver the rice to the school point on proper weightment in the presence of the teacher concerned and in no case short supply or delivery shall be made by the agent to the schools. The weighing machine to be taken by the transporting agent must be sealed and stamped by the Inspector of Legal Metrology, Angul. The miller and agent both will be held responsible for taking delivery of the stock, shortage and damage noticed if any during transit and no shortage will be allowed to the agent. The quality and quantity of the foodstuff being transported may be inspected by the Govt. officials authorized by Collector during transit and also at the delivery point.
- 4 The tenderer should submit the following documents along with the tender paper. In absence of any document / paper in the tender form will be liable for rejection by the competent authority. The tenderer shall have to produce the original documents if necessary before the Tender Committee for verification.
 - I Original tender paper duly signed by the tenderer as token of acceptance of the terms and condition of the tender.
 - II Original money receipt in support of purchase of the tender documents from the office of the District Project Management Unit, MDM, Angul.
 - III Attested copy of the Valid miller License owned by the tenderer under Rice milling Industry Act.
 - IV The Selected Miller should be supply the food grain with Fair Average Quality (FAQ) and sample of the above food grain send to the District Education Office, Angul for testing the quality
 - IV Attested copy of valid Income Tax / Pan Card.
 - V Valid Solvency Certificate for Rs 30, 00,000/- (Rupees Thirty Lakh) from the competent authority should be furnished along with the tender paper failing which the tender will be liable for rejection.
 - VI Earnest Money of Rs 5,00,000/- (Rupees five lakh) only in shape of Demand Draft / NSC / Term Deposit duly pledged in favour of Collector, Angul shall be furnished along with the tenders. Tender without Earnest Money will be liable for rejection. Cash/Cheque and Bank Draft shall not be accepted. Any deviation to the above stipulation will entail complete rejection the tender paper. No tenderer shall be allowed to withdraw his tender / Earnest Money deposit until the tender is finalized. In case the successful tendere refuse to be the. The E.M.D of the unsuccessful tenderer shall be refunded after finalization of the tender, whereas the EMD of the successful tenderer will be kept as Security Deposit and will be released after successful completion of contract period settlement of payment thereof and audit of such account and after obtaining the audit report. The Collector/DEO, Angul are not liable for payment of any interest on the Security Deposit or any depreciation thereof. The breach of any terms and conditions as per agreement and failure/ unwillingness to undertake to supply of food grain work as per selected tenderer within the time limit after acceptance of his tender may lead to forfeiture of EMD. The selected miller will be black listed for any



other Govt. Tender if he fails to perform the duties as per agreement in timely, regular supply of food grains on proper weighment.

- 5 The successful tenderer shall have to enter into registered agreement with Collector, Angul as per the terms and conditions mentioned in the specified agreement format within 7 days of intimation of acceptance of his tender. The cost of such registration will be paid by the tenderer.
- 6 Payment shall be made against submission of bills on completion of the delivery of the stocks as per the orders of competent authority on production of printed serially numbered delivery challans duly acknowledged by the recipient of the stock to whom it concerned and as per the approved rate in corporate in the agreement. The District Education officer – cum- District Nodal Officer (MDM), Angul shall have the right to deduct and adjust any amount found recoverable towards loss and damage or both. The payment will be made subject to availability of funds under Transportation charges head under MDM programme and no advance payment will be made. If the food grain found without FAQ rice the miller shall held responsible and the amount deducted from the cost of food grain.
- 7 The Cost of food grain shall be changed as per Govt. instruction and it will be changes time to time.
- 8 The existing contractor shall supply the food grain to the concerned school point from the selected miller as per the existing rate.
- 9 Good conduct, dealing with officials shall be an implied condition for continuance as transporting Agent and miller.
- 10 The Collector, Angul may terminate the contract for violation of terms and conditions of agreement as well as change of policy in the govt. or any reason to be recorded in writing or applicable for only doorstep of miller.
- 11 In case of violation of conditions of Tender the miller and Agent will be booked under IPC, Essential commodities Act. Prevention of foods Adulteration Act. and prevention of Black Marketing Act.
- 12 The right of acceptance of tender rests with collector, Angul who does not bind himself to accept the lowest tender and also reserves the rights to cancel or reject any or all the tenders without assigning any reason thereof. In case of any dispute the orders/decision of the Collector, Angul will be final & binding.
