

2. The materials will be delivered at Block Headquarter.
3. The Quoted rate will include the cost of marble/Tiles, cost of engraving and cost of transportation & Taxes as applicable etc.
4. The suppliers will be paid by the DRDA, Angul centrally based on the quantity supplied.
5. The successful bidder will execute an agreement at DRDA level for supply of material at approved price valid for one year from the date of agreement.
6. The Bid document can only be downloaded from the District website i.e. www.angul.nic.in (The bidder has to attach a Demand Draft worth Rs. 5000/- (Rupees Five Thousand) only in favour of "Project Director, DRDA, Angul" payable at Angul from any Nationalized Bank towards cost of bid documents).


