**TERMS AND CONDITIONS FOR ENGAGEMENT OF TRANSPORTING CONTRACTOR UNDER SNP
IN ANGUL DISTRICT**

Sealed tenders are invited from the intending Registered Transport Contractors / Agencies / Individuals for engagement of Transporting Agency for under taking transportation of food stuff from FCI depots to WSHGs points / OSCSC depots to AWC points under Supplementary Nutrition Programme in Angul District.

The tender paper complete in all respect (Technical & Financial) with all required documents are to be submitted to the DSWO, Angul on or before **16.01.2019 , 1.00 PM** by Registered / Speed post only. The tender will be opened on the same day at **3.00 PM** in presence of the members of the Tender Committee and the Tenderers or their authorized representatives.

The tender received beyond the scheduled date and time shall not be taken into consideration. The Authority reserves the right to reject /cancel any or all tenders without assigning any reason thereof and shall bear no liability what so ever consequent upon.

Approximate quantity of rice Q.14000 and wheat Q 19000 will have to be transported during the year.

Approximate value of the food grains is Rs.80, 00,000/- and the maximum ceiling rate of transporting cost is limited to Rs. 75/- per quintal inclusive of loading / unloading and other incidental charges irrespective of distance.

1. The tender paper should be filled in properly and legibly without any correction/overwriting and must be typed copy/computer type copy. No opportunity shall be given to the tenderer to rectify or amend any defect detected at the time of scrutiny. The rates should be written both in words and figures in the tender. The rate quoted should be final and tenderer shall not be allowed to change the same under any circumstances and it should be valid for 1 year.

2. The tenderer should submit its Technical Bid in a envelop superscribed "Technical Bid for engagement of T.C under SNP", the financial Bid in a envelop superscribed "Finical Bid for engagement of T.C under SNP" and both the envelops must be kept in a big cover superscribed "Tender for engagement of T.C under SNP".

3. Affidavit of declaration that the tenderer abide to agree by all the terms and condition s of the tender should be submitted.

4. Valid agent's license registered for common carriers under the Carriage by Road Act /Rule from the Competent Authority shall be furnished along with the tender paper.

5. The Money Receipt or DD (any Nationalized Bank) of Rs. 5,000/- Rupees (Five thousand) only in favour of DSWO Angul payable at Angul towards cost of tender fees must be enclosed with the tender paper.

6. Earnest Money Deposit of Rs. 1,00,000/- Rupees (One Lakh) only in shape of Fixed Deposit Receipt (at any Nationalized Bank) dully pledged in favour of Collector Angul must be enclosed with the tender paper.

7. Certificate of past experience from the Government or Semi Govt. Organization in handling with storage & transporting of similar type of food grains to be furnished along with the tender paper .The Accepting Authority shall have the right not to accept tender of registered firms/agency/individual who have not performed satisfactorily preceding years under Govt. of Odisha.

8. The E.M.D. of the unsuccessful tenderer shall be refunded after finalization of the tender, whereas the E.M.D. of the successful tenderer will be kept as security deposit and will be released after successful completion of contract period. The authority is not liable for payment of any interest on the Security Depositor any depreciation thereof.

9. The up to date GST Return, Up to date Income Tax Return, Self attested copy of PAN card must be attached with the tender paper.

10. List of trucks owned by the tenderer with up to date documents (Xerox copy self attested) shall be furnished along with the tender . The tenderer should have minimum four trucks in his name and must have coverage under valid Transporting Insurance.

11. The tenderer or any of his family members should not be storage Agent/Miller Agent /Retailer of P.D.S. Rice. An affidavit to this said effect is to be furnished along with the tender paper.

12. The tenderer should file an affidavit either from the Executive Magistrate or from the Notary in support of that, he/ she have no criminal background and is not black listed.

13. It is the responsibility of the transporting agent to lift the wheat from FCI Depot on proper weightment and deliver the same to the WSHGs (THR Point) on proper weightment in the presence of the SHG members and to lift the rice from OSCSC Depot on proper weightment and deliver the same to the AWWs on proper weightment in the presence of the of the Janch Committee and in no case of short supply or delivery shall be made by the Transport Contractor to the WSHGs /AWWs. The weighing Scale to be taken by the Transport Contractor must be sealed and stamped by the Inspector of Legal Metrology, Angul. The Transport Contractor will be held responsible for taking delivery of the stock, shortage and damage noticed if any during transit and no shortage will be allowed to the Transport Contractor. The quality and quantity of the foodstuff being transported may be inspected by the Govt. officials authorized by Collector during transit and also at the delivery point. There shall not be any change both in quality and quantity of the food grains during transportation by the Transport Contractor and for any shortcomings in this front the Transport Contractor shall be responsible and this shall be treated as misappropriation by the Transport Contractor. If any misappropriation is noticed during checking, a penalty shall be levied which would be equivalent to 10 times of the cost of misappropriated food grains apart from initiating criminal cases.

14. Recent Solvency Certificate for Rs. 20,00,000 /-Rupees (Twenty Lakh) only from the competent authority (R & DM Dept.) must be attached with the tender paper.

15. Bank Guarantee for Rs.2,50,000 /- Rupees (Two Lakh Fifty Thousand) only from any Nationalized Bank should be furnished with the tender paper.

16. The successful tenderer shall have to enter into registered an agreement with the Collector, Angul as per the terms and conditions mentioned within 7 days of intimation of acceptance of his tender.

17. Payment shall be made against submission of bills on completion of the delivery of the stocks as per the orders of competent authority, on production of printed serially numbered delivery Challans duly acknowledged by the recipient of the stock to whom it concerned as per the approved rate incorporated in the agreement and dully verified by the CDPOs concerned. The District Social Welfare Officer, Angul shall have the right to deduct and adjust any amount found recoverable towards loss and damage or both. The payment will be made subject to availability of funds under Transportation Charges head under SNP and no advance payment will be made. GST will be deducted from the bill as per rule.
18. Good conducts, dealing with officials shall be an implied condition for continuance as Transporting Agent.
19. The Authority may terminate the contract for violation of terms and condition of agreement as well as any change of policy in the Govt. or for any reasons to be recorded in writing.
20. In case of violation of conditions of Tender the Agent will be booked under IPC, Essential Commodities Act. Prevention of Food Adulteration Act. & Prevention of Black Marketing & Supply Act.
21. The right of acceptance of tender rests with Collector, Angul who does not bind himself to accept the lowest tender and also reserves the rights to cancel or reject any or all the tenders without assigning any reason thereof. In case of any dispute the orders/decision of the Collector, Angul will be final & binding.
