1. Sealed tenders in prescribed proforma are invited from the intending buyers for sale of 96 nos of confiscated vehicles of Angul Forest Division as per the terms and conditions mentioned below. The vehicles will be sold on "as is where is basis" and to complain regarding the condition of the vehicles will be entertained afterwards.
2. The intending tenderers are requested to inspect the confiscated vehicles kept at the location as noted against each well in advance before submitting the tender paper. Submission of sealed tenders will be taken as a sufficient proof of the tenderers to have inspected the vehicles put for sale and no further complain regarding the vehicles will be entertained on any circumstances.
3. The intending tenderer will have to submit an earnest money (EMD) for vehicles as mentioned against each in the list furnished in a separate sheet in shape of Bank Draft/ Bankers Cheque drawn in favour of the Divisional Forest Officer, Angul Division payable at SBI, Angul main Branch alongwith the sealed tender. Tender papers without EMD in shape of Bank Draft/ Bankers Cheque will be rejected out rightly.
4. If a tenderer wants to bid for more than one vehicle, then he has to apply in separate tender form for each vehicle alongwith separate Bank Draft/ Bankers Cheque. In case of successful tender the EMD amount will be adjusted towards sale value. In case of unsuccessful tender the amount of EMD will be refunded within 7 days after the date of tender.
5. The undersigned reserves the right to accept any bid or reject any or all bids or cancel/ withdraw invitation for bid without assigning any reason thereof for such decision. Such decision, by the Divisional Forest Officer, Angul Division shall not be subject to question by any bidder and the said Divisional Forest Officer shall bear no liability whatever consequent upon such a decision.
6. The tender papers will be received upto 11.06.2019 from 7.00 A.M to 1.00 P.M on working days in the office of the undersigned. The sealed tender papers may be submitted to the Divisional Forest Officer, Angul Division, At/P.O./Dist- Angul by Regd. /Speed Post or in person in a box kept for the purpose in the Division Office. Once the tenderer files the tender paper, it will be presumed that he has already fully satisfied himself about the present condition of the vehicle. The tender paper will be opened on dt.12.06.2019 at 10.00 Am in presence of the tenderers or their authorized representatives with proper identity proof i.e. Adhar Card or any authentic identity proof.
7. The highest tenderer shall have to deposit 50% of the accepted highest tender amount including the EMD amount and full tax amount under GST as per the rule in force immediately after announcement for the tender result and the rest 50% within 15 days from the date of issue of the ratification order or confirmation of the tender.
8. In case of default in payment of highest tender amount by the successful tenderer within the stipulated period from the date of the ratification order, 50% of the tender shall be forfeited to Govt. and the vehicle will be put to a fresh tender sale. Since these are confiscated vehicles seized in forest offence cases, no tools, R.C Books and implement will be supplied to the highest tenderers. The undersigned is not liable for any pending road taxes and for charges of ownership of these confiscated vehicles only.
9. The vehicles shall not be delivered to the highest tenderer till full payment is made and other formalities are fulfilled.
10. The highest tenderers shall take delivery of the vehicle from the spot within 07 (Seven) days from the date of ratification and full payment of the highest tender amount failing which no claim will be entertained on any circumstances later on.
