TENDER CALL NOTICE

As per the letter No: 27037, Date: 08.10.2015 of Finance Department of Government of Odisha, sealed tender are invited from reputed travel agencies/ tour operators/ private individuals for 1 no's of private vehicles having seating capacity not more than 10 seats including driver for official use for supervision of Rural Housing work in Block Office, Kishorenagar on monthly rent basis which shall confirms following terms and conditions (Annexeture I & II).

The vehicle must be in road worthy condition, shall not be more than 5 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Valid Fitness Certificate, Contract carriage permit, Proof of up to tax payment etc. which are mandatory for paying of vehicle.

- 1- The driver must have a valid driving license of light motor vehicle, transport passenger vehicle.
- 2- The driver should be well behaved, gentle and obedient in nature.
- 3- A sum of Rs- 5,000/- (Rupees Five Thousand only shall be deposited by the intending bidders in shape of A/C pay Bank Draft drawn in favour of Biju Pucca Ghara Yojona- BPGY, Kishorenagar Block to be drawn at ICICI Bank, Dhaurapali Branch and submit along with the tender as security deposit. After the completion of tender process the amount will be refunded to the unsuccessful bidders.
- 4- The monthly rate of hire charges as corid should not exceed Rs 20000/- per month as quoted.
- 5- The vehicle is to be used for one year from the date of the contract. If required the contract order to be extended for further more period and the contract can be terminated within the contract period.
- 6- The vehicle must achieve a fuel efficiency of 10 kms for Block RH supervision work.
- 7- The details of make and year of manufacturing of the vehicle, registration number, miles covered for ltrs, name of the driver with valid driving license no and period of validity should be separately provided in the General Bid information to be furnished with the Tender (Annexeture II).
