**AUCTION SALE NOTICE**

Sealed tender are invited for auction sale of one mobile Van bearing No.- OR02L-2548 of Odisha State Civil Supplies Corporation Ltd, Angul on as is and where is basis, including the present status of vehicle documents. The intending tenderer are requested to submit their tender in plane paper offering their bid duly sealed along with one Bank Draft worth Rs 5000.00 (Rupees Five Thousand) only drawn in any Nationalization Bank as EMD in favour of District Manager, OSCSC Ltd, Angul. The tenderers are required to send the tender papers exclusively through registered post/ speed post/ courier service. The last date of receipt of tender is Dt. 10.07.2019 till 5 PM. The tender paper received after the specified date and time as mentioned above, shall not be entertained and the same shall be out rightly rejected. The sealed tender shall be opened on Dt. 16.07.2019 at 11 AM, in the office chamber of Addl. District Magistrate, Angul in presence of the tenderers or their authorized representatives. The tenderer may inspect the vehicle kept in the premises of FSD, FCI Angul at Caltax Chakka, Angul on any officials working day -10.30 AM to 5 PM.

The upset price of the vehicle No. OR02L-2548 – Rs.120,000/-

**Terms and Condition:**

1. Quotation should be sent by mentioning " Auction sale of the vehicle No OR02L-2548 on the top of the closed envelope containing EMD.
2. The tenderer with highest bidding shall be selected by the competent authority. He shall deposit 25 % of the bid amount immediately on the spot and rest amount shall be deposited within seven days or at the time of taking delivery of the vehicle , whichever is earlier.
3. The EMD of all unsuccessful tenderers will be refunded to them on the same day.
4. If price offered by sealed tenderers are found less than upset price then competent authority may go for fresh Auction sale or negotiation may be made with all present tenderers to fetch minimum upset price as desired by authority.
5. In case successful tender fail to deposit 75 % of balance auction price at the time of taking delivery of vehicle within 7 days , his tender paper will be cancelled and the EMD along with 25 % deposit will be forfeited.
6. The highest bidder will take the vehicle within 15 days of deposit of the total amount failing which ground rent of Rs 100/- per day will be charged till final disposal of vehicle.
7. After change of ownership in favour of highest bidders or cancellation of registration of the vehicle at RTO, BBSR/ Angul the vehicle will be handed over to the highest bidder subject to production of documents in this respect.
8. Where the ground rent so charged exceed the price deposited by the tenderer, shall cease to have any right on the vehicle and amount so deposited by him will be adjusted towards ground rent. The vehicle shall become absolute property of the Corporation free from all encumbrances and it will be disposed of by fresh auction / tender as case may be.
9. The successful tenderer/ party shall have to deposit the cost alongwith statutory dues like sales Tax/ GST etc as admissible under Rules.
10. The District Manager, reserves the right to accept or reject any or all the tender paper without assigning any reason thereof.
