

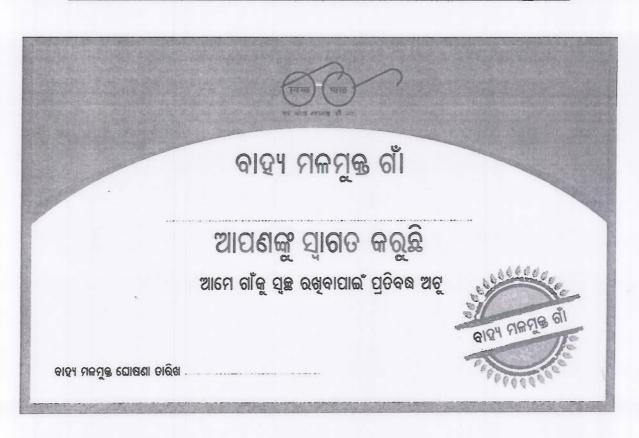

- The bidder must have a valid PAN (Permanent Account Number).
- EMD worth Rs. Rs. 68,000/- (Rupees Sixty Eight Thousand) only in shape of 2 years Fixed
  Deposit/ Term Deposit/ Postal Account Deposits duly pledged in favour of "District Water
  & Sanitation Mission (DWSM), Angul" from any nationalized bank along with the technical
  bid.
- An amount worth Rs. 6,000/- (Rupees Six Thousand) only in shape of Demand Draft made
  in favour of "District Water & Sanitation Mission (DWSM), Angul" payable in Angul from
  any nationalized/ scheduled commercial bank towards cost of Bid Documents along with
  the technical bid towards cost of Bid documents (Non-refundable).
- Experience certificate for executing any Government/ PSU work of similar nature during last Financial Year. (The work order copy can be attached as a proof of the work executed). Further the bidder must have completed at least one assignment worth Rs. 20.00 Lakh during the last 03 financial year for any Government organization (certificate from the competent authority/ work Order in which the amount has been mentioned or copy of agreement where value of the work has been mentioned).
