- ii. Regarding payment/contribution of Service Tax, EPF etc. wherever is applicable, the service provider will remain responsible for that.
- iii. Sweeper engaged for the purpose should be well behaved, gentle, of healthy disposition and free from any addiction to drug/alcohol.
- iv. The Quotation received, which is incomplete or after the scheduled date and time shall be summarily rejected.
- v. The authority reserves the right to reject all or any Quotation without assigning reason thereof.
- vi. The intending service providers should produce valid registration certificate.

The sealed quotations should reach O/o the Principal, Police Training College, Angul latest by 20.01.2020 (T) speed post/registered post or by hand addressed to O/o The Principal Police Training College, Angul. The sealed quotations shall be opened and scrutinized by the Technical Committee at O/o The Principal, Police Training College, Angul in presence of bidders or their authorized representatives, if any, so desired and the short listed bidders shall be informed for further follow-up actions. The date of opening of sealed Quotations shall be intimated in due course of time.
