Order No. 545 /Emer. Dt. 06.04.2020 /

Whereas, it is imperative to adopt strict social distancing and isolation measures to contain the spread of COVID-19 which is playing havoc in many countries across the world including India.

And Whereas, the Govt. of Odisha vide R&DM Deptt. Notification No.1706/R&DM dtd.13.03.2020 has declared as a "DISASTER" under Section 2(d) of Disaster Management Act 2005 for the State of Odisha.

And whereas National Disaster Management Authority (NDMA), Govt. of India in exercise of powers conferred under section 6(2) (i) of Disaster Management Act 2005 has directed the state Govt. / State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the National Executive Committee constituted under the said Act to issue necessary guideline in this regard.

And whereas, the National Executive Committee in pursuance of the said order of the NDMA and in exercise of its power under section 10(2) (i) of National Disaster Management Act, 2005 has issued necessary guidelines to the State Governments vide its order No.403/2020-DM-I(A) dtd. 24.03.2020.

And whereas in pursuance of the said order of NDMA Govt. of India, the Govt. of Odisha vide Notification No.2035/R&DM dtd. 27.03.2020 ordered lockdown in entire State of Odisha until midnight of 14th April 2020 with a view to ensure strict social distancing and isolation to contain the spread of COVID-19.

Now, therefore in exercise of the power conferred under Section 34 (b) & (c) of National Disaster Management Act-2005 and clause 8(iii) of Notification No.9570/H dated 03.04.2020, I Sri Manoj Kumar Mohanty, OAS (SAG), Collector & District Magistrate, Angul being the Empowered Officer do hereby order that:

- > All weekly Hats/Markets shall remain closed till lockdown is over.
- > The shopkeepers who fail to maintain social distancing, the said shops shall be closed by the authority.
- > All the shops of the district which are permitted to open during lockdown period shall remain open from 06.00 AM to 01.00 PM every day.
- > The dealers who are permitted to supply the grocery items to consumers through home delivery, can continue their services without continuing the counter sale after 01.00 PM.
- No pillion on two-wheelers shall be allowed except in case of any medical emergencies.
- > The persons who are moving/loitering without any reason shall be kept under institutional quarantine for a period of 14 days.

The order will be came into force with immediate effect.
