

Quotation Call Notice

Rate of the following Items are invited in sealed covers from manufacturers, whole sale dealers and intending suppliers having past experiences for supply of the required inputs and annual turnover above 50 lakh with following terms and conditions :-

1. (i) For supply of Neem based , Organic fertilizer and pesticides the Intending Bidders must have valid FRC (Fertilizer Registration Certificate)/ manufacturing and marketing license as well as pesticides selling license from competent authority and enclose a copy of each with the Quotation.
(ii) The intending Bidders must have enclosed the quality testing report from certified laboratory of Govt. of Odisha in Agriculture Department and test report must confirm to the FCO 1985 and respective pesticides rule. The packing must carry the date of manufacture , date & expiry and manufacturing batch No. also for De-oiled Neem Cake, Organic Fertilizer and pesticides.
2. The supply rate should include cost of transportation and delivery at farmer's point.
3. The intending bidders must have enclosed valid ITC Certificate, GST clearance certificate and proof of past experiences and also audit report of previous year, Copy of PAN Card, Bank Account No. (Xerox copy of Bank Statement).
4. The supplier of wire mesh must adhere to the as specification and mention the address of manufacturing unit.
5. The Bidders have to submit EMD of 50,000/- only in shape of DD payable to Deputy Director of Horticulture, Angul along with the quotation paper. The EMD of unsuccessful Bidder will be returned back to their account through RTGS.
6. The successful intending bidder must deposit 2% of the total value of supply as EMD in shape of Bank draft in favour of Deputy Director of Horticulture, Angul within 3 days including Rs. 50,000/-. It shall be refunded to the supplier after successful completion of the delivery of the items and on conformation of the quality within three months or it will be rejected for untimely delivery and quality on pro-rate basis.
7. The intending bidders must submit Rs. 500/- as processing fees (non-refundable) in shape of demand draft payable to Deputy Director of Horticulture, Angul payable at any Bank at Angul.
8. The payment will be made by DRDA through the indenting agencies after supply of materials and for organic fertilizer after receipt of testing report from the notified laboratories after final delivery of the products. This testing shall be conducted by the Deputy Director of Horticulture, Angul.
9. The Quotation intending to participate may submit the sealed cover by post/courier service. The last date of the receipt of sealed cover in the office of the Deputy Director of Horticulture, Angul on or before 25.06.2020. The committee shall not be responsible for any postal delay.
10. The sealed covers shall be opened in presence of members of purchase committee and the Quotationers or their authorized representative on 26.06.2020 at 10.00 AM in the office of the Deputy Director of Horticulture, Angul. The decision of the committee shall be final.
11. Non-submission of required documents the EOI seems to be automatically rejected for the Tender process.
The Purchase Committee reserves the right to cancel the bidding or supply order without assigning any reason thereof.
