- 1.2 The bidder(s) are to submit their tenders in separate sealed covered envelopes for technical bid and price bid by super scribing Cover "A" (Technical Bid) & Cover "B" (Price Bid) and both the sealed covers should be put into a third outer Cover, which should be super scribed as "Tender for the Blood Bank Lab. Reagent/Kits/Blood Bag & Consumable items to the Office of Chief District Medical & Public Health Officer ,D.H.H, Angul, Orissa" & Tender Reference No. _.
- 1.3 The Sealed tenders "Cover A" (Technical Bid) submitted by the tenderers will be opened by the member of the purchase committee in the office chamber of Chief District Medical & Public Health Officer, DHH, Angul at ~~3:30 PM~~ on 30.09.2020.
