







TERMS AND CONDITIONS

1. The sealed tenders in closed cover super scribed by "TENDER FOR VEHICLE" will receive in the office of the Chief District Medical & Public Health Officer, Angul on or before **12.10.2020** during the working hours. The tenders so received will be opened on **dt.13.10.2020 at 10.30 A.M.** by the members of the auction committee in presence of the tenders in the office of the undersigned.
2. The vehicle put to the tender will be disposed of on "AS IS WHERE IS BASIS ALONG WITH OUT STANDING ROAD TAX LIABILITY IF ANY" to be paid by the accepted tender NO PENDING ROAD TAX WILL BE PAID BY THIS OFFICE.
3. Separate tender for each vehicle is to be submitted.
4. The intending bidders may inspect the vehicle during office hour.
5. Intending bidders shall have to enclose a bank draft/ bankers cheque of Rs. 1000/- (Rupees one thousand) only drawn on State bank of India, Angul in favour of Chief Distirct Medical Officer, Angul towards EMD for each vehicle along with the tender paper failing which the tender will not be accepted.
6. The EMD of Rs. 1000/- of the unsuccessful tenderer shall be refunded to them on the day of opening tender paper.
7. The tender quoting highest price shall deposit 25% of the accepted tender immediately on confirmation of acceptance of tender and the rest amount within -7 (seven) days. In case of failure to pay the amount, the deposit including earnest money will be forfeited and the vehicle will be put to fresh tender.
8. The vehicle will be handed over to the successful tenderer after making the full payment of the accepted tender money.
9. The tenderer will remove the vehicle from the site within 07 (seven) days of payment of money in full. The safeguard and custody and of the vehicle shall be the responsibility of the tenderer . No claim or complain in this regards shall be entertained by the undersigned.
10. Ground charge @1% of the tender money will be charged for each day or part of the day from the successful tenderer till the vehicle is removed from the site in case of failure to remove the same within the stipulated time period.
11. Where the ground charge exceeds the sale price deposited, the tender cease to have any right on the vehicle. The amount deposited by the tenderer will be adjusted towards the ground charge and the vehicle become absolute property of the Govt., from encumbrances and disposed of by fresh tender.
12. If the competent authority does not approve any tender, the amount deposited by the tenderer will be refunded without interest and acceptance of the particular tender will be null and void.
13. The undersigned reserves the right to accept/ reject any or all tender without assigning any reason thereof.
