Tender Call Notice

No. 5 Dt. 08.10.2020

Sealed tenders are invited from interested reputed Travel Agencies / Tour operators or private individuals for providing one number of Diesel Driven Vehicle (Preferably One Bolero) as mentioned below:


Type of Vehicle	Maximum Hire Charge (in Rs.)	Minimum Average Mileage in K.M. per Ltr.
Bolero	As per Govt. rate	12 K.M./litre

The following Term and conditions must be fulfilled by the successful bidders for providing the vehicle on hire on monthly rent basis for Official use by Panchayat Samiti, Pallahara:

1. The vehicle must be in Road Worthy condition, and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contact Carriage Permit, proof of up to date tax payment etc, which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of **Rs.5,000/- (Rupees Five Thousand)** only shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the **Block Development Officer, Pallahara** and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge to be quoted separately in the general bid information (excluding fuel). The maximum hire charges per month is fixed as per Govt. notification.
6. The Vehicle must achieve a fuel efficiency of 12 Kms. per litre.
7. The details of the make and year of manufacture of the Vehicle, Registration No, Mileage (Kms. covered per liter) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Tender (Annexure-I).




