N.B.:- Bank draft /pay orders or Bankers cheque from any schedule bank in favour of CDM & PHO, Angul shall not be considered as E.M.D.
4. The sale of the bid document shall start from Dt. 17.11.2020 during office hour and close on dt.27.11.2020 up to **5.00 P.M.** in the office of CDM & PHO, Angul. The bid documents can be purchased by depositing tender paper cost in shape of Bank draft only from any schedule bank in favour of ZSS, Non-NRHM, Angul.
5. Bids must be delivered in the Tender Box having identification no 1 (CDM & PHO, Angul) 02 of 2020-21 in an envelope super scribed with the name of the work. The bids received by any other means will not be considered for tender.
6. Bid documents can be purchased from all the offices mentioned against the work as well as in the office of the undersigned against a Non- refundable fee towards cost of the documents in the demand draft issued from any schedule bank payable in favour of **CDM & PHO, Angul, payable at Angul.**
7. The bidders shall produce original valid Registration certificate, PAN, GST registration certificate within **5 (five) days** of opening of the tender before the undersigned for verification, otherwise his/her bid shall be declared as non-responsive and thus liable for **rejection**.
