(Expression of Interest for District Ombudsman under MGNREGA)

As per instructions of Govt. in P.R & D.W Department, fresh expression of interest is invited from willing persons to be engaged as Ombudsman in Angul District for redressal of grievances and disposal of complaints relating to implementation of the MGNREGA Act for tenure of two years extendable not more than twice by one year each based on performance appraisal process or till the incumbent attains the age of 68 years whichever is earlier. The Ombudsman shall be allowed compensation in the form of a fee of Rs.1000/- (One thousand) only per sitting with maximum upper limit of Rs.20000/- (Twenty thousand) only per month. Again the Ombudsman shall work as per Govt. of Odisha, P.R & D.W Department Letter No.2357, dtd.04.02.2021.

Eligibility Criteria:-

1. Person of eminent standing and impeccable integrity with at least 10 years of experience in public administration/ law/ academic/ social work/ management.
2. Mandatory experience in working with people or community organization.
3. She/He should not be member of political party or a banned organization.
4. Must be physically active person and capable of conducting field tours, inspections and visit to remote rural areas in the district.

The willing persons fulfilling above criteria may submit their written expressions in the prescribed proforma along with copy of the required documents to the Collector-cum-DPC, MGNREGA on or before dt.06.04.2021 through Regd. Post/Speed Post. The applications received after due date, due to postal or any other delay will be rejected.
