The Block Development Officer, Kishorenagar on behalf of the Governor of Odisha invites Percentage rate composite bid in single cover system for the works as detailed in the table, from the class of eligible contractors as mentioned in Col.4(four) , registered with the State Government and contractors of equivalent grade / Class registered with Central Government/ MES / Railway, to be eventually drawn up in PWD P-I form, for execution of Building(Composite work i.e Civil Work, P.H Work and E.I Works).The proof of registration from the appropriate authority shall be enclosed along with the bid. If successful, the bidder who has not registered under State Government has to register under the State PWD in appropriate class of eligibility before signing the agreement. Bidders may submit bids for the following work.

2. Bid documents consisting of plans, specification, the schedule of quantities and the set of terms & conditions of contract and other necessary documents can be seen in the office of the Panchayat Samit, kishorenagar during office hours every day except on Sunday & Public holidays till last date of sale and receipt of tender paper. Interested bidders may obtain further information at the same address.
3. Bids must be accompanied with E.M.D. (Bid Security) of the amount specified for the work in the table at Col.5 above in shape of N.S.C./K.V.P./P.O.T.D / Post Office Savings Pass Book / Deposit receipt of any Scheduled Bank (Valid minimum one year from the date of receipt) duly pledged in favour of **Block Development Officer, Kishorenagar**. Bids without E.M.D. or in other shape will not be considered and liable for rejection.

N.B:- E.M.D. in shape of Cash / Pay Orders or Bankers Cheques / Bank Draft is not acceptable.


4. The sale of the bid document shall start from **dt.23.03.2021** in the office of the **Block Development Officer, Kishorenagar** during office hour. The cost of bid document as mentioned in col. No-6 has to be paid by each bidder in shape of demand draft drawn in favour of **Block Development Officer, Kishorenagar** from any nationalized bank. Sale of bid document will be closed at 5.00 P.M on dt. 12.04.2021. The bid document may also be downloaded from website (<http://www.angul.nic.in>). During this period. The intending tenderers down loading the tender document has to pay the cost of tender paper for each set **Rs.10,000/-** in shape of **bank draft payable at SBI, Dimirimunda in favour of Block Development Officer, Kishorenagar**.
5. Bids shall be received in the office of the Panchayat Samiti, Kishorenagar, Angul till **Dt. 16/04/2021 up to 5.00PM-through Registered Post/Speed Post**. The authority will not be held responsible for postal delay in the delivering of the documents or non-receipt of the same..
6. Bidders shall submit original affidavit regarding authenticity of their documents. Bids shall be accompanied with attested true copy of valid registration certificate, GSTIN and PAN card, otherwise his/her bids shall be declared as non-responsive and thus liable for rejection. The original certificates of the successor bidder are to be produced before **Block Development Officer, Kishorenagar** for verification.
7. **Bidders can submit one tender paper for the particular work. Submission of more than one tender paper by a bidder for the particular work will be liable for rejection.**
8. The bid will be **opened at 11. 00 A.M. on dt. 20/04/2021** in the office of the undersigned, in the presence of the bidders or their authorized representatives, who wish to attend. If the office happens to be closed on the last date of sale and receipt / opening of the bids as specified, the bid will be sold and received / opened on the next working day at the same time and venue.
9. If the rate quoted by a bidder is more than 15% less of tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimal up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders/ their authorized representatives, the tender inviting authority/ his authorized representative and Accounts Officer of Block will remain present.

10. Additional performance security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e estimated cost put to tender minus the quoted amount as Additional Performance Security in shape of N.S.C./K.V.P./P.O.T.D / Post Office Savings Pass Book / Deposit receipt of any Scheduled Bank (Valid minimum one year from the date of receipt) duly pledged in favour of **Block Development Officer, Kishorenagar** within 7(seven) days otherwise the bid shall be cancelled and the security deposit be forfeited. Further proceeding for blacklisting shall be initiated against the bidder.
11. For building and other Construction Workers Welfare Cess @ 1% (One Percentage) of the cost of construction shall be deducted from bills.
12. Other details can be seen in the bidding documents.
13. The undersigned reserves the right to cancel/reject in partly/fully or all tenders without assigning any reasons thereof.


