### **TENDER CALL NOTICE**

1. Sealed tender in plain paper are invited so as to reach the Office of the undersigned i.e. Collector, Angul on or before Dt.23.04.2021 up to 11.00 A.M. and would be opened on the same day at 11.30 AM for disposal of Govt. vehicle (Diesel-Ambassador Car) bearing No.OR-19C-0001 of Collector, Angul. In the tender paper full name, complete address and bidding amount is required to be indicated.
2. The intending competitors may inspect the vehicle in the office garage of ADM, Angul on any working day during office hours. The intending competitors shall be required to pay earnest money deposit amounting to Rs.1000/- (Rupees one thousand) only in shape of Bank Draft in favour of Additional District Magistrate, Angul payable at State Bank of India, Angul which shall be subject to refund immediately except in case of highest bidder accepted by the competent authority. The Bank Draft must be accompanied with tender paper. The tender paper not accompanied by the required Bank Draft will be rejected. The upset price of the vehicle is Rs.37,000/- (Rupees thirty seven thousand) only.
3. Offers received by Dt.23.04.2021 up to 11.00 A.M. from the date of announcement shall be opened and considered in the presence of tender(s) or their authorised agent (s). The highest bidder at or above the minimum price shall be approved by the competent authority then and there. The highest tenderer shall deposit 25% of the amount immediately after the announcement and the rest shall be deposited within 7days of the approval of the bid.
4. On failure to make payment as aforesaid, the deposits (including earnest money) shall be forfeited and the vehicle put to fresh tender as the case may be.
5. The vehicle shall not be delivered to the tenderer/party until after full payment and compliance with the requisite formalities. Tools, implements and spare parts shall not be delivered with the vehicle.
6. The tenderer/party shall remove the vehicle from the site within 7 (seven) days from the date of depositing the full amount of of tendered/negotiated money. Custody or safeguard of the vehicle shall be the responsibility of the tendered/party and no claim or complaints on that accounts shall be admissible.
7. On failure to remove the vehicle within the time as aforesaid, ground rent at the rate of one percent of the tendered/negotiated money shall be charged for each day or part of the day till the removal of the vehicle from the site.
8. Where the ground rent so charged exceeds the sale price deposited, the tenderer/party shall cease to have any right on the vehicle. The amount deposited by him shall be adjusted towards the ground rent and the vehicle shall become absolute property of Govt. free from all encumbrances and disposed of by fress sealed tenders as the case may be.

9. The authority reserves the right to accept or reject all the tenders without assigning any reason thereof.
