## TENDER CALL NOTICE

- Sealed Tenders are invited from the interested parties, in the prescribed format for disposal of Govt. Jeep (Mahindra & Mahindra) bearing No. OR-02-5899 of the District Welfare Officer, Angul.
- The last date of receipt of tender paper in the O/o the DWO, Angul is by <u>11.08.2021</u> through Regd. Post /Speed Post only. No tender paper shall be accepted by hand.
- 3. The intending parties may inspect the vehicle in the premises of the Collectorate, Angul on any working day within the due date during office hours. The intending parties are required to pay the cost of the tender paper amounting to Rs.1000/-(Rupees One thousand) only in shape of Bank draft drawn in favour of District Welfare Officer, Angul payable at State Bank of India, Angul which is not refundable. The intending parties are also required to pay earnest money deposit amounting to Rs.2000/- (Rupees two thousand) only in shape of Bank Draft in favour of District Welfare Officer, Angul. Payable at State Bank of India, Angul which shall be subject to refund immediately except in case of Highest offer accepted by the Committee. The prescribed tender paper is available in the district Web sitewww.angul.nic.in the Bank drafts must be accompanied with the tender paper. Non Submission of said Bank Drafts with tender paper shall be rejected. The up-set price of the vehicle is Rs.20, 000/- (Rupees twenty thousand) only.
- 4. Offers received within due date <u>11.e.8.20</u>2 from the date of announcement, shallbe opened on <u>12.e.8.2024</u>At 11:00 AM in the office chamber of Collector, Angul in presence of the tenders on their Authorized Agents. The highest offer shall be accepted by the Committee then and there. The highest tender shall deposit 50% of the bid amount immediately after the announcement and rest shall be deposited within 7 days of the approval of the bid.
- 5. On failure to make payment within the due date, the deposits (including earnest money) shall be forfeited and the vehicle shall be put to fresh tender as the case may be.

- The vehicle shall not be delivered to the tenderer party unless full payment is 6. made and compliance with the requisite formalities. Tools, Implements and spare parts shall not be delivered with the vehicle.
- 7. The tenderer party shall remove the vehicle from the site within 7 days from date of depositing of the full amount of tendered/ negotiated money. Custody or safeguard of vehicle shall be responsibility of the tender/party end no claim or complaint on that accounts shall be admissible.
- 8. On failure to remove the vehicle within the time as aforesaid, ground rent at the rate of 1% of the tendered/negotiated money shall be charged for each day or part of the day till the removal of the vehicle from the site.
- 9. Where the ground rent so charged exceeds the sale price deposited, the tenderer party shall cease to have any right on the vehicle. The amount deposited by him shall be adjusted towards the ground and vehicle shall become the absolute property of Govt, free from all encumbrances and disposed of by fresh sealed tenders as the case may be.
- 10. The authority reserves the right to accept or reject all the tenders without assigning reason thereof.
