Sub: Restriction of access to ERONet system from whitelisted IP addresses. Reg. Sir/Madam.

In order to strengthen the security of ERONET system, it has been directed to implement the restriction of access to ERONet system from whitelisted IP addresses only by 15 September 2021. The whitelisting of IP addresses require fixed IP address(es) from where the system is being accessed. This requires either internet leased line or Broadband/FTTH connection with Fixed IP address. The ERONET system are being primarily accessed from office of CEOs, DEOS, EROS & AEROs and all offices may not have fixed IP connectivity at present. It is observed ISP's tariff plan that approx. Rs 2000 per annum may be the additional cost for one fixed IP address per Broadband/FTTH connection.

CEO's are requested to collect the detail of fixed IP addresses from all AEROS/EROS/DEOs through DEOs and inform to ECI/CDAC to whitelist same for access of ERONET before 15th September 2021. In case of non-availability of Fixed IP connection with any office, CEOs may instruct the concerned officer to convert their connection with fixed IP plan within by 14th September 2021 and inform same to ECI /CDAC so that there will not be any issue in accessing the ERONET otherwise it would not be accessible.
