Sub: -SHGs participation in Paddy Procurement: KMS-2021-22

Madam/Sir,

As per the decision of the Cabinet, different departments are provisioning Government business in procuring goods & services through SHGs.

In that context, SHGs have been engaged in paddy procurement under FS & CW Dept in some districts. Since the procurement operation is system driven, it is enabling SHGs to provide services in a transparent manner. There is lot of positive feedback among the SHGs already running purchase centres in paddy procurement operations. Mission Shakti has manpower presence at the district & block. Handholding support is provided on regular basis to SHGs taking up any activity.

In the CMO review meeting held on 12.08.2021, it has been decided to engage more SHGs in paddy procurement operations.

Hence, it is requested to involve willing and capable SHGs to run paddy purchase centers in the districts in the coming KMS if they are not engaged so far & more SHGs may be involved in the districts where they are already procuring paddy. This will enable them to provide services to the farmers of their area and also augment their livelihood activities.
