AUCTION NOTICE FOR DISPOSAL OF NON-SEEDS ON LOT BASIS

Spot auction of Non-Seeds (Lot / Lots wise with maximum 200 qtls.) will be conducted on **20.12.2021** 11.00AM at **Angul** Go-down of Zonal Manager, OSSC Ltd, Boudh.

Pre-Qualification/ Conditions: -

The participating parties should produce copy of the following documents: -

1. The bid should be valid up to 31 Jan 2021.
2. GST Registration Details.
3. Photo copy of PAN Card.
4. Duly signed Authorization and identity card of the person (Aadhar card/ PAN Card/ Driving License/ Voter Id card etc.), who is representing the party, participating in the auction is required to be submitted before auction.
5. The party should deposit EMD of Rs. 10,000/- (Rupees Ten Thousand) only in the SBI, Old Town Branch, Bhubaneswar, Account No -34782065884, IFS Code-SBIN0003108, Current Account and submit proof of deposit, before participation in the auction process.
