

The sealed tenders should reach the office of the District Welfare Officer, Angul on or before 25/07/2022 by 05.30 PM. The sealed tenders will be opened on 26/07/2022 at 11.00 AM by the District Level Purchase Committee in the Collectorate , Angul.

TERMS & CONDITIONS

1. Rate quoted should include all taxes & cost of transportation.
2. The tender paper in sealed cover must be accompanied with the Processing Fee of Rs.1000/-, GST Registration certificate & Pan Card.
3. The tender paper is to be addressed to the District Welfare Officer, Angul and "Tender for supply of utensils to the Sibida Ashram School of ST & SC Development Department" should be super scribed on the top of the cover.
4. The successful tenderer will have to supply all the utensils to the hostel points within 15 days from the date of receipt of supply order.
5. If the supplier fails to supply the materials within the stipulated period, the supply order will stand automatically cancelled.
6. The tender is liable for rejection, if it does not include the Processing Fees, GST Registration Certificate & Pan Card.
7. The payment shall be made after post delivery inspection by the members of the Purchase Committee.

9. The undersigned reserves the right to reject any or all the quotations without assigning any reason thereof.


