1. **Executive Officer, Talcher Municipality, Talcher** on behalf of Governor of Odisha invites **Percentage bids** in **double cover** system for the works details in the table from class of contractors mentioned in Col.4 below registered with the State Government and contractors of equivalent grade/class registered with Central Government/ MES/Railways to be eventually drawn up in PWD-F-2 (Now P-1) form for execution of civil works, on production of definite proof from the appropriate authority. But successful bidder other than State/MES/ Railways/CPWD in equivalent rank has to register under the State PWD before signing the agreement.

Bids must be accompanied by scanned copies of financial instruments towards **Cost of bid documents in shape of Demand draft** issued from any **Nationalized Scheduled Bank prepared in favour of the Executive Officer, Talcher Municipality, Talcher** payable at Talcher separately as mentioned at column 7. of the above table .

4. Additional performance security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Demand Draft/Term Deposit Receipt pledged in favour of the Divisional Officer within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for Blacklisting shall be initiated against bidder
5. The amount put to tender is exclusive of GST and GST will be paid as per the direction of the Finance Department applicable from time to time.
6. The tender will be evaluated and disposed off as per rules and procedures laid down in OPWD code, OGFR volumes-I and OM Act & Rules-1950.
7. The bid documents will be available in the website : [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) from 11.00 AM of Dt.22.07.2022 to 5.00 PM of dt.08.08.2022 for online bidding.
8. The bidder must possess compatible **Digital Signature Certificate (DSC)** of Class-II or Class-III.
9. Bids shall be received **only "online" on or before dt. 08.08.2022 up to 5.00 PM.**
10. Bids received online shall be opened at 3.00 PM on dt.10.08.2022 in the office of the Executive Officer, Talcher Municipality, Talcher in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
11. The sealed main envelop duly prescribed with the Bid Reference No. only and containing the documents mentioned at Sl. 4 above should be dispatched through Regd. Post/ Speed Post addressed to the Executive Officer, TALCHER MUNICIPALITY, At / P.O. Talcher Town, Dist.Angul (Odisha), Pin - 759107 so as to reach his office on or before **1.00 PM of Dt. 10.08.2022** . TALCHER MUNICIPALITY will not be held responsible for postal delay, if any, in the delivery of the documents and/or non-receipt of the same in time. TALCHER MUNICIPALITY shall also not be held responsible for any damage caused to the documents during transit & handling.
12. Sealed envelopes containing the documents mentioned in Cl. 4 above and the corresponding tenders/bids, if otherwise not rejected, shall be opened at **3.00 PM** onwards of **Dt. 10.08.2022** in the office of the Executive Officer, TALCHER MUNICIPALITY, At / P.O. Talcher Town, Dist.Angul (Odisha), Pin – 759107. If the tenders could not be opened on **Dt.10.08.2022** for any reason beyond the control of Executive Officer, TALCHER MUNICIPALITY, then the same shall be opened on the next official working/functioning day at **3.00 PM** onwards.
13. An applicant or any of its constituent partners of whose contract for any work has been rescinded or who has abandoned any work in the last five years, prior to the date of the bid, shall be debarred from qualification. An affidavit to the effect is to be furnished in Schedule-F. Non furnishing of the information in prescribed affidavit in Schedule-F, the bid document shall be summarily rejected.
14. The received tender shall remain valid for a period of 180 days from the date of opening of the bid.
15. It should be under stood clearly that no claim what-so-ever will be entertained to extra items of work, extra quantity of any item besides agreement quantity unless written order is obtained from the Engineer-in-charge and rate settled before the extra items of work or extra quantity of any items of work is taken up.
16. **Bid Security / Earnest Money Deposit (EMD)**

There is no provision regarding "Bid Security" should be kept in the bid documents and only provision for "**Bid Security Declaration**" shall be kept according to the Finance Deptt. letter No.8484, Dt.05.04.2022. This provision has been extended from 18.3.21 upto 31<sup>st</sup> December 2022.


Additional performance Security :-

Amendment to Para 3.5.5. (V) Note – II of OPWD Code Vol. I by Modification vide Works Deptt. O.M. No.4559/W, Dt.05.04.2021

Additional Performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price / rates than the estimated cost put to tender shall have to furnish Additional Performance Security (APS) as per the tubular form given below in shape of Term Deposit Receipt pledged in favour of the Executive Officer, Talcher Municipality / Bank Guarantee in favour of the Executive Officer, Talcher Municipality from any Nationalized / Scheduled Bank in India counter guaranteed by its local branch office in Bhubaneswar within seven days of issue of Letter of Acceptance (LoA) by the Divisional Officer (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit / Bid Security shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder.






