The total Bid Price shall also cover all the Contractor's obligations mentioned in or reasonably to be inferred from the Bidding Documents in respect of Supply, erection, testing, inspection, Transportation to site/stores, all in accordance with the requirement of Tender Documents. The Bidder shall complete the appropriate Price Schedules enclosed in

format stating the Taxable value for each item including Packing & forwarding, freight & insurance, loading & unloading charges, GST. Price evaluation shall be carried out on the basis of total value of work including GST.

#### 13 VALIDITY

#### 15 MATERIALS:

#### 16 QUANTITY VARIATION:

Owner reserves the right to increase or decrease the quantity of materials and services specified in the schedule of requirement up to 20% of the tender quantity without any change in price or other terms and conditions. The contractor may conduct a joint survey of the work site together with the Engineer-In-Charge, to derive the actual quantity of work to be undertaken.

#### 17 QUALITY OF WORKMANSHIP:

The work should be carried out as per standard of REC specification and CEA guidelines. If any work is found unsatisfactory by "Owner/Executive Engineer-In-Charge/ Any authority Representative of the Owner" of the work, the contractor shall have to dismantle the same and rectify without any extra financial cost.

#### 18 Transportation:

Transportation of required materials during the execution of work shall be arranged by the contractor at his own cost and this rate is included in the total order price as stated above.
