## TENDER CALL NOTICE

1. Sealed tenders are invited from the intending persons, in the prescribed format for disposal of govt. Jeep (Mahindra & Mahindra) (DIESEL) bearing no. OR-19-E-1300 of the Tahasildar & Executive Magistrate, Athmallik.
2. The last date of receipt tender paper in the Office of the Tahasildar, Athmallik is 25.10.2022 by Regd. Post. / Speed Post only. No tender paper shall be accepted by hand.
3. The intending parties may inspect the vehicle in the premises of the Tahasil Office, Athmallik at any working day within the due date during office hour. The intending parties are required to purchase tender paper by paying to Rs.100/- (Rupees One hundred) Only in shape of Bank Draft drawn in favour of "Tahasildar, Athmallik" payable at State Bank of India, Athmallik. The intending parties are also required to pay earnest money deposit amounting to Rs.1500/- (Rupees One thousand five hundred) only in shape of Bank Draft in favour of Tahasildar, Athmallik payable at State bank of India, Athmallik which shall be subject to refund immediately except in case of highest offer accepted by the Competent Authority. The prescribed tender is available in the Dist. Website- [www.angul.nic.in](http://www.angul.nic.in). The Bank Draft must be accompanied with the tender paper. Non-submission of Bank Draft of Rs.100/- towards cost of Tender Paper and Rs.1500/- towards E.M.D. tender paper shall be rejected. The up-set price of the vehicle is Rs.30,000/- (Rupees Thirty thousand) only.
4. Offers receive within due date i.e. 25.10.2022 from the date of announcement, shall be opened on 26.10.2022 at 11.30 A.M. in the office chamber of Tahasildar, Athmallik in presence of tenderers or their Authorize Agents. The highest offer shall be accepted by the Committee then and there. The highest tender shall deposit 25% of the bid amount immediacy after announcement and the rest 75% of amount shall be deposited within 07 days of the approval of bid.
5. On failure to make payment within the due date, the deposits (including earnest money) shall be forfeited and the vehicle shall be put to fresh auction as the case may be.
6. The vehicle shall not be delivered to the tender/ party unless full payment is made and compliance with the requisite formalities. Tools, implements and spare parts shall not be delivered with the vehicle.
7. The tender/party shall remove the vehicle for the site within 07 days from date of depositing of the full amount of tendered/ negotiated money. Custody or safe guard of vehicle shall be responsibility of the tender/ party and no claim or complaint on that accounts shall be admissible.

8. On failure to remove the vehicle within the time as aforesaid, ground rent @1% of the tendered/negotiated money shall be charged for each day or part of the day till removal of the vehicle from the site.
9. Where the ground rent so charged exceeds the sale price deposited, the tendered/ party shall cease to have any right any on the vehicle. The amount deposited by him shall be adjusted towards the ground rent and vehicle shall become the absolute property of Government, free from all encumbrances and deposited of by fresh sealed tenders as the case may be.
