1. **Block Development Officer, Kaniha** on behalf of Governor of Odisha invites **Percentage bids** for the works 2nos details in the table from class of contractors mentioned in Col.4 (four) below registered with the State Government and contractors of equivalent grade/class registered with Central Government/ MES/Railways to be eventually drawn up in PWD( P-1) form for execution of Building (Civil Work). The proof of Registration from the appropriate authority enclosed along with the bid if successful, the bidders who have registered under the State Government has to register under 1 PWD in appropriate class of eligibility before signing the agreement. Bidders may submit bids for any or all the following work.

2. Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms and conditions contract and other necessary documents can be seen if the office of the Panchayat Samiti Office, Kaniha during office hours everyday except on Sunday and Public Holidays till last date of sale and receipt of tender paper. Interest bidders may obtain further information at the same address.
3. No EMD(Bid security) is to be required but bidders have to submit "Bid Security Declaration" certificate along with the bid as per works department office memorandum No.5984 dated.27.04.2021 and finance department Lettter No.8943 dt.18.03.2021.
4. The sale of BID Documents shall start from **10 AM on dt.22-10-2022** in the office of the Block Development Officer, Kaniha during office hour. The cost of bid documents as mentioned in col. No-5 has to be paid by each bidders in shape of demand draft drawn in favour of Block Development Officer, Kaniha from any nationalized bank. Sale of Bid documents will be closed at **05.00 PM on dt.31-10-2022**. Bid document will be received in the Office of the Block Development Officer, Kaniha through **speed post or registered post only** from during office hours only. No Box/hand delivery of Bid Document will be entertained. The undersigned is not responsible for any postal delay. If any, in the delivery of the documents or –non-receipt of the same. The Bid document may also download from the website [www.anquil.nic.in](http://www.anquil.nic.in) during this period. The intending tenderers downloading the tender document has to pay the cost of tender paper for each set of Rs.6000/- in shape of bank draft payable at SBI, Telisingha in favour of Block Development Officer, Kaniha.
5. Bids must be received through **speed post having identification No.KAN-01/2022-23** kept in Kaniha Block for the purpose.
6. Bidders shall submit original affidavit regarding authenticity of their documents along with their bids. Bids shall be accompanied with attested true copy of valid registration certificate, GSTIN and PAN Card, experience certificate otherwise his/her bids shall be declared as non-responsive and thus liable for rejection. The original certificates of the lowest bids shall be produced before Block Development Officer, Kaniha for verification.
7. Bidders shall submit tender paper for a particular work. Submission of more than one tender by same for a particular work will be liable for rejection.
8. Engineering Contractors desirous to avail the facility of exemption of EMD is required to submit affidavit effect that he/she has not yet availed the facility for more than two works during the current financial year in which his/her tender will be rejected.
9. The Bid will be opened at **10.30 AM on dt.01-11-2022**, in the Office of the undersigned in the presence of all the bidders or their authorized representatives, who wish to attend. If the office happens to be closed on the last sale and receipt/opening of the bids as specified, the bid will be sold and received /opened on the next two dates on the same time and venue.
10. The lowest bidder has to submit the Additional performance security amount within 7 days of award of tender.
11. For building and other Construction Workers Welfare CESS @ 1% (One Percentage) of the cost of construction shall be deducted from bills.
12. Other details can be seen in the bidding documents.
13. The undersigned reserves the right to cancel/reject in partly/fully or all tenders without assigning any reasons thereof.
14. If the rate quoted by a bidder is less than 15% of tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. If all goes with same price transparent Lottery system will be applied.
