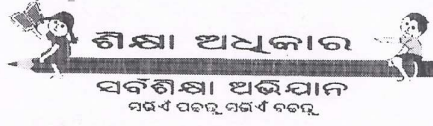



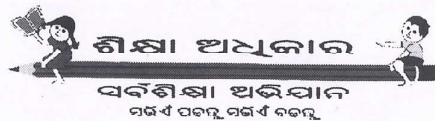

ANNEXURE – I

ELIGIBILITY CRITERIA

The firm must be registered with respective authorities like GST, as per rules. Copy of Income Tax Return for the last two financial years, i.e. 2020-21 and 2021-22 must be submitted.

- i. The firm should be in existence for over 2 years in the trade with the resource materials (copy of proof must be attached). Firms having Income Tax Return for 2 years may also participate.
- ii. The office of the firm should be located in Odisha so that immediate replacement of defective materials can be ensured.

4. All entries in the tender form should be legible and filled clearly. No underwriting / overwriting are allowed. If the space provided for furnishing information is insufficient, a separate sheet duly signed by the authorized person may be submitted.
