Sealed quotations/ tenders are invited from interest reputed Travel Agencies/ Tour Operators or Private individuals for providing 01 (one) nos. of vehicle i.e "BOLERO" which shall conform to the Terms & Conditions (Annexure – II) for "Paddy procurement operation for the KMS-2022-23 in the Office of the CSO-cum-District Manager, O.S.C.S.C. Ltd., Angul on monthly rent basis."

1. The vehicle must be in Road Worthy Condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, Proof of up to date Tax payment etc. which are mandatory for plying of vehicle.
2. The driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport vehicle.
3. The driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs.5000/- shall be deposit by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the CSO-cum-District Manager, O.S.C.S.C. Ltd., Angul and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The minimum fuel efficiency of the hired vehicle must be 10 (Ten) Kms per litre.
6. The details of the make and year of manufacture of the vehicle, registration no., mileage (Kms covered per litre) and name of the driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the quotation/ tender (Annexure – III).
7. The tender paper shall be dropped in the tender box available in the office of CSO-cum-District Manager, O.S.C.S.C. Ltd., Angul on all working days

from 10.00 A M to 5.30 P.M. except holiday w.e.f 17.11.2022 to 01.12.2022. The tender paper received after 01.12.2022 , 5.30 P.M shall not be entertained in any circumstances. The Tender shall be opened on 02.12.2022 ,11.00A.M in presence of the bidders/authorized representatives in the Office chamber of Addl. District Magistrate(General), Angul.




