Notification No. 359 /dated. 12.12.2022

1. Sealed tenders in prescribed proforma (to be sold at Athmallik Division Office) are invited from the intending buyers for sale of 27 (Twenty seven) confiscated vehicles of Athmallik Forest Division as mentioned below. The vehicle will be sold on " as is where is basis" and no complain regarding the condition of the vehicle will be entertained afterwards.
2. The intending tenderers are hereby advised to obtain the sale list and tender forms on payment of Rs 100/- (Rupees one hundred) only in cash (Non-refundable) for each set of paper.
3. The intending tenderers are requested to inspect the confiscation vehicles kept at the spot as noticed against each well in advance before submitting the tender paper and no complaint shall be entertained after the tender sale is completed. Submission of sealed tenders will be taken as sufficient proof of the tenderers to have inspected the vehicle put for sale and no further complain regarding the vehicles will be entertained under any circumstances .
4. The intending tenderers will have to submit an earnest money for vehicles as mentioned against each in the list furnished below **in shape on Bank Draft/ Bankers cheque drawn in favour of the Divisional Forest Officer, Athmallik Forest Division Payable at SBI , main branch ,Athmallik and original receipt of Rs-100/- (Rupees one hundred only)** towards the purchase of tender paper alongwith the sealed tenders. Tenders papers without EMD in shape of Bank draft/ Bankers cheque and the original receipt of Rs.100/- towards the purchase of each tender paper will be rejected out rightly.
5. If a tenderer wants to bid for more than one vehicle, than he has to apply in separate tender form for each vehicle along with separate Bank Draft/Bankers cheque for EMD. In case of unsuccessful BID, the EMD amount will be adjusted towards sale value. In case of unsuccessful bid the amount of the EMD Shall be refunded on the date of sale.
6. The undersigned reserves the right to accept any bid or, reject any or, all bids or cancel/withdraw invitation for bid without assigning any reason thereof for such decision. Such decision , by the Divisional Forest officer, Athmallik Forest Division shall not be subject to question by any Bidder and the said Divisional Forest officer shall bear no liability whatsoever consequent upon such a decision.
7. The tender papers will be received from dt. 13.12.2022 to 27.12.2022 on any working day during 11 AM to 4 PM in the office of the undersigned .The intending tenderers required to submit a copy of Aadhar CARD or authentic identity proof

issued by Govt of India or Odisha for their identification alongwith the tender paper by Regd post or in person dropping in a Box , Once the tenderer files the tender paper, it will be presumed that he has already full satisfied himself about the present condition of the vehicle. The tender papers will be opened on 28.12.2022 at 10.30 AM in presence of tenderers of their authorised representatives with proper identity proof i.e Aadhara Card and any other Government identity proof, issued by either Govt of India (or Govt of Odisha) .

8. The highest tenderer shall have to deposit 50% of the accepted highest tender amount including the EMD amount and full tax amount under GST as per the rule in forces immediately after announcement of the tender result and the rest 50 % within 15 days from the date of issue of the ratification order or confirmation of the tender .In case of unsuccessful tender the amount of the EMD shall be refused soon after declaration of the result.

9. The balance amount due for payment for every successful bid can be paid in shape of cash and/ or Bank Draft/Bankers cheque in which some part of the bid amount has to be paid in shape of Bank Draft/bankers cheque minatorily.

10. In case of default in payment of highest tender amount by the successful tenderer within the stipulated period from the date of the ratification order; 50 % of the tender amount including the EMD deposited on the date of opening of the tender amount including the EMD deposited on the date of opening of the tender shall be forfeited to Govt and the vehicle will be put to a fresh tender sale. The clearance of Road Tax and all other documentation etc shall be the responsibility of the successful tenderers.

11. The vehicle shall not be delivered to the highest tenderer till full payment is made and other formalities are fulfilled.

12. Once the sale is ratified in the name of the highest tenderers all the liabilities , will be of the tenderers & no claim will be made for any paper and tools etc. which are not available in this office as the vehicles have been seized under forest offence cases. The undersigned is not liable for any pending road taxes and charges of ownership of these confiscated vehicles.

13. The successful tenderers shall remove the vehicles from the site within 45 days from the date of deposit of the full amount , failing which ground rent at the rate of 1 % of tender money shall be charged for each day or part of the day till its removal. Custody or safeguard of the vehicle shall be the responsibility of the tenderer and no claim or compliant on that account shall be admissible.
