TENDER CALL NOTICE

Sealed tender in plain paper are invited so as to reach the office of the undersigned i.e. Sub-Collector Office, Talcher on before dt. 20.12.22 up to 3.00 PM and will be opened on the same day at 4.00PM for disposal of Govt. vehicle (JEEP) bearing No.OR-19E1771 of Sub-Collector, Talcher. In the tender paper full name, complete address and bidding amount is to be indicated.

2. The intending competitors may inspect the vehicle in the office circuit house/Inspection Bunglaw of Sub-Collector's Office, Talcher on any working day during office hours. The intending competitors shall be required to pay earnest money deposit EMD amount of Rs.1000/- (Rupees One thousand) only in shape of Bank Draft in favour of Sub-Collector, Talcher payable at State Bank of India, Hatatota, Talcher which shall be subject to refund immediately except in case of highest bidder accepted by the competent authority. The Bank Draft must be accompanied with the tender paper. The tender paper not accompanied by the required Bank draft will be rejected. The up set price of the vehicle is Rs.45,000/- (Rupees forty Five thousand) only.

3. The highest bidder at about the minimum price shall be approved by the competent authority then and there. The highest successful bidder shall deposit 25% of the amount immediately after the announcement and the rest shall be deposited within 7 days of the approval of the bid.

4. On failure to make payment as aforesaid, the deposits (including earnest money) shall be forfeited and there will be a fresh tender for the vehicle.

5. The vehicle shall not be delivered to the successful bidder /party until there is full payment and compliance with the requisite formalities. Tools, implements and spare parts shall not be delivered with the vehicle.

6. The successful bidder /Party shall remove the vehicle from the site within 7(seven) days from the date of depositing the full amount. Custody or safeguard of the vehicle shall be the responsibility of the successful bidder /Party and no claim or complaints on that accounts will be admissible.

7. On failure to remove the vehicle within the time as aforesaid, ground rent at the rate of one percent of the tendered/negotiated money shall be charged for each day or part of the day till the removal of the vehicle from the site.

8. Where the ground rent so charged exceeds the sale price deposited, the tenderer/party shall cease to have any right on the vehicle shall become absolute property of Govt. free from all encumbrances and disposed off by fresh sealed tenders as the case may be.

The authority reserves the right to accept or reject all the tenders without assigning any reason on thereof.
