EXPRESSION OF INTREST (EOI)


For production documentary film

The interested firms having experience in Agricultural field may offer their sealed EOI regarding rate contract (i.e. rate/per minute programme) latest by 05.01.2023 up to 2.00 P.M. which will be opened by a committee on same day at 3.00 P.M. in presence of bidder of their authorized representatives. The EOI is sealed cover are to be submitted at the office CDAO Angul during office hours on working days only.

Documents to be submitted:

1. Profile of Agency.
2. Registration certificate for making documentary film.
3. The agency should have empanelled under Information & Public Relation Department (O)/DA& FP(O)/IMAGE,BBSR. Copy of empanelment to be submitted.
4. Self certificate stating that agency has not been black listed in the past.
5. Average annual turnover of 3 consecutive years must be 20 lakhs or above under production of documentary films in Agriculture .Turn over statement of last 3 years certificate by chartered accountant has to be furnished.
6. The agency must have furnished a copy of their GSTIN registration certificate and clearance up to November-2022.
7. The agency must have experience in conducting documentation and preparation of video CDs for last 3 years under the Department of Agriculture, Odisha (Copies of work order/agreement to be furnished year-wise).
8. Quoted price per minute should be clearly mentioned in the bid and should be inclusive of taxes.
9. The authority has all right to accept or reject of the assignment will be made by assigning reason thereof, beside receipt of incomplete forms after due date and time will be rejected.
10. Payment to the agency on the assignment will be made by assigning authority/office for the delivers submitted by the agency and as per the prevailing approved rates of information and public relation department, Govt. of Odisha Letter NO.SN/07/2017-14601/ IPR, Dated 17.12.2018 and DA&FP letter No.1112 Dt.17.09.2019 after successful completion of the assignment along with the GST Bill.




