**TENDER CALL NOTICE FOR PROCUREMENT OF VETERINARY MEDICINES,
FEED ADDITIVES & MEDICAL CONSUMABLES**

Tenders are invited in sealed cover in two bid systems from wholesalers/ Distributors/ C & F agencies and suppliers approved by manufacturers dealing with Veterinary Medicines, Feed additives and Medical consumables to participate in competitive bidding for supply of same during the year 2022-23 on rate contract basis. Bidders have to submit bids for three category of items, viz: Veterinary Medicines (In category 'A'), Feed additives (In category 'B') and Medical Consumables (in category 'C'). They have to submit technical bids in one envelop for all categories and price bid/s separately for three categories if they need to participate in three categories of items. The technical bid and price bids packed in a separate envelop can be submitted to the under signed through Regd. Post/Speed Post or can be dropped in Sealed drop box kept for the purpose at office of the under signed by Dated. 21.03.2023, 3 PM. The tenders can be submitted from 11 AM of 06.03.2023 and the tender documents will be available in the website of Angul NIC from 06.03.2023. The Technical bids of the tender will be opened on Dated. 22.03.2023 at 11 AM by Tender evaluation committee in presence of Bidder or his authorized representative at office of the under signed. Tender papers can be down loaded from Collectoarate, Angul website <https://angul.nic.in>. Other details information about this tender is available on this website. Tender processing fee as required by this tender can be remitted in shape of demand draft only, drawn from any Schedule Commercial Bank, in favour of "Chief District Veterinary Officer, Angul". The bidder has to submit all the required documents mentioned in Section VI. Non submission of any document and tender submitted in any inappropriate manner may be liable for rejection.





SECTION II

General Definitions & Scope of Contract

1. General Definitions

- 1.1 *Department* means Fisheries & Animal Resources Development Department, Government of Odisha.
- 1.2 *Government* means Government of Odisha. *Bid / Tender Inviting Authority* is the CDVO, Angul, who on behalf of the User Institution/Government or the funding agencies calls and finalize bids and ensure supply, procured under this bid document.
- 1.3 *Tender Evaluation Committee & Technical Committee* are Committees so constituted by CDVO, Angul to decide on the purchase of the drugs/Medicines & consumables to be procured.
- 1.4 *User Institutions* are the Govt. animal health care institutions of Angul district under F&ARD Dept., Government of Odisha for which the items under this bid are procured.
- 1.5 *De-recognition/ Debarment* – the event occurring by the operation of the conditions under which the bidders will be prevented for a period of 3 years from participating in the future bids of Tender Inviting Authority, more specifically mentioned in the Specific Conditions of Contract and General Conditions of Contract of this bid document, the period being decided on the basis of number of violations in the bid conditions and the loss/hardship caused to the Tender Inviting Authority on account of such violations. Withdrawal or non-compliance of bid terms and conditions after the issuance of Supply Order will lead to de-recognition/ debarment of the successful bidder.

2. Scope

- 2.1. The bids are invited for the supply of the items, the details of which are mentioned in Annexure I, Annexure-II & Annexure-III, needed for the Govt. animal health care institutions of Angul District sole.
- 2.2. The bidders can't withdraw their bid after opening of technical bid, within the minimum bid validity period of 180 days & also after accepting the Letter of Intent.

2.3. Withdrawal or non-compliance of agreed terms and conditions after the execution of agreement will lead to invoking of penal provisions and may also lead to de-recognition/ debarment.

SECTION III

GENERAL TERMS AND CONDITIONS

1. **The Chief District Veterinary Officer, Angul, Odisha** (Tender Inviting Authority) working under Fisheries & Animal Resources Development Department, Govt. of Odisha for providing Animal health care services, requires various Veterinary Medicinal, Feed additives & medical consumable items to be used by various Subordinate health care institutions(hereinafter referred to as user institutions).
2. This tender is floated in 2 Bid system for 3 (Three) category of items i.e.:
 - A. **Veterinary Drugs/Medicines**
 - B. **Feed Additives**
 - C. **Medical Consumables**
3. Sealed tenders will be received by Dated.21.03.2023 up to 3 PM. by the Authorized Officer at Office of the Chief District Veterinary officer, Angul through **Courier/Speed Post/ Regd. Post only** (not by hand) for the purchase and participation in the open tender for supply of "Veterinary Drugs/Medicines, Feed additives and Medical Consumables" for a period of one year. **Any tender received after the scheduled date & time will be rejected.** The tender inviting authority will not be responsible for any postal delay.
4. The bidder(s) shall have to submit their tender in separate sealed envelopes, i.e. one for technical bid by super scribing Cover "A" (Technical Bid) & Cover "Bs" (Price Bids) (separate sealed covers for each category).The Technical Bid and Price Bids should be put in to a third Cover, which should be super scribed as "**Tender for Veterinary Drugs/Medicines, Feed Additives & Medical Consumables**". On this cover the address of Sender and Receiver need to be clearly mentioned.
5. The Sealed tenders "**Cover A**" (Technical Bid) submitted by the bidders will be opened at the Office of the CDVO, Angul by the Tender Evaluation Committee in presence of Bidders or their authorized representative. In situation of absence of participation of Bidder/ authorized representative during the process, opening of Technical bid cannot be stopped. The bidder will have no right to claim any sort of imposition to make the process null and void. But due to any unexpected unwanted situation, if the process of opening of technical bid has to be stopped, the notice for next date of opening the technical bid will be displayed in the office notice board of CDVO, Angul and also it will appear in the official website of Collectorate, Angul. The Technical Bids will be opened on Dated. 22.03.2023 at 11 AM.
6. No tender documents shall be accepted after the expiry of scheduled date and time.
7. The details of items and specification which one can appreciate to submit bid are mentioned at Annexure -I for category A, Annexure-II for category B and in Annexure-III for category C items.

8. Rate should be quoted in Indian Currency (with paisa in two decimals only), both in words and figures against each item as the payments will be made in Indian currencies only (Annexure-IIIA, Annexure-IIIB, Annexure-IIIC). The tenderer shall not quote the rate for any item other than the item specified in the list.
9. The GST shall be charged as per the guide lines given by the Finance Dept., Govt. of Odisha/India from time to time. TDS of 2% of GST will be made as per rule.
10. EMD/Bid security deposit has been exempted vide Finance Deptt. Office Memorandum No. 8484/F Dated 05.04.2022 up to 31st December 2022. Instead the bidder has to submit "Bid Security Declaration" in prescribed format.
11. The interested bidder can download the Entire Tender Document from the website <https://angul.nic.in>. He can have the tender documents from office of the CDVO, Angul from accounts section by making a Govt. deposit of non-refundable Rs.2000/- (Rs. Two thousand only) towards the tender processing fee.
12. All the sheets of technical Bid along with bid document shall be serially numbered and dully attested by the bidder. **Any deviation will liable for rejection of bid.**
13. Quotation should be type written without any correction or overwriting and each page of quotation paper should be numbered.
14. Payment shall be made after delivery items in proper condition and specification through RTGS after submission of bills/ vouchers.
15. The rate contract once approved should remain valid for one year from the date of approval.
16. Medicines supplied shall not have expiry date not less than one year.

17. Tender processing fee

The firms desirous to participate in the bid process shall have to submit Tender Processing fee in shape of Demand draft of Rs.2000/- (**Non-refundable**) (Rs. Two thousand only) drawn at any Nationalized bank in favor of "Chief District Veterinary Officer, Angul". The demand draft or Govt. money receipt of Rs.2000/- is to be attached with the Technical bid documents.

18. ELIGIBILITY CRITERIA

Veterinary drug Distributors /Wholesalers / C&F Agents/ Veterinary drug Manufacturers authorized supplier for Category -A and Firms dealing with Medical consumables are eligible to participate in the tender provided, they have:

- (i) Valid Wholesale/ Distributor Drug License/ Trade License from the Drug Controller (O)/ competent authority.
- (ii) Firm should be authorized by Manufacturer for sale/ distribution of particular

products/items incorporated in this tender.

- (iii) Bidder shall have the capacity to supply at least 50% of the ordered item within 07 days and rest of the items within 15 days of placement of supply order. Failure of supply within stipulated period may result in cancellation of order followed by forfeiture of performance security deposit.
- (iv) Valid ISI/CE/US FDA/ WHO GMP/ GMP Certificate of the products from manufacturer end as per the specifications mentioned against each item are necessary. (For items enlisted in (Annexure- I, Category-A).
- (v) Valid ISO certificate of Manufacturer whose products bidders are offering. (For items enlisted in Annexure- I, Category-A).
- (vi) Bidders need to have experience of one year in supplying Veterinary medicines (for item/s under Category A) to State Govt. /Central Govt. /State or central Govt. PSUs. In support of experience the bidder has to submit experience certificate or copy of the bills of the product supplied along with documents submitted for technical bid.
- (vii) Annual Turnover
The bidder should have annual average turnover of Rs.10 Lakh each per year for the last three financial years i.e. during 2019-20, 2020-21 & 2021-22. Bidder shall have to produce turn over certificate from Chartered accountant.
- (viii) Shall have PAN Card & valid local OGST registration
- (ix) Valid/up-to-date TAX (I.T&GST) return certificate. GST should be cleared up to financial year 2021-22. (31st March 2022)
- (x) Shall have local office in Odisha with local contact person's address and telephone no. (Annexure-VI)
- (xi) Non-Conviction Certificate from the competent authority.
- (xii) Bidders who have been blacklisted either by the Tender inviting authority or by any State Govt. or Central Govt. organization OR PSU is not eligible to participate in the tender for that item.

19. Submission of Samples for verification:

- (i) Bidders shall have to submit samples of their quoted items being packed in a sealed packet as non-refundable. The samples will be verified for visual quality by the tender evaluation committee. In case of any doubt on quality and quantity the product may be sent to higher laboratory as per the decision of the team headed by the tender inviting authority. The details of the list of item(s) for which samples have to be submitted are mentioned in Annexure-I, Annexure-II & Annexure-III.
- (ii) The samples may be sent through courier or handed over physically to the authorized officer from office of the tender inviting authority on receiving necessary acknowledged slip from the officer. The samples need to reach the office before

- (iii)The bidders shall not claim any payment towards verification / consumption / use of such samples for quality, user friendliness etc. for evaluation purpose. The samples which belong to lowest responsive bidder after price comparison will be kept at the O/O undersigned as Master Sample (even if not consumed/utilized).
- (iv)The Tender Inviting Authority's contractual right to inspect, test and, if necessary, reject the goods after the goods' arrival at the final destination shall have no bearing of the fact that the goods have previously been inspected and cleared by Tender Inviting Authority's inspector during sample verification as mentioned above.

20. COVER-B (PRICE BID)

- (i) The price bid format giving the quoted rate for Veterinary drugs /feed additives/ medical consumables should be sent in a separate sealed covers here after called **Cover "Bs" (Price Bids)**.
- (ii) The bidder shall have to submit separate sealed price bids for each category of items quoted. If bidder is participating in different categories and submits one sealed price bid for different category of items, the whole bid of said bidder shall be rejected outright. Cover-B (Price Bid) will be opened only of the bidders who qualify in evaluation of Technical Bid (Cover-A) and/or items qualified in sample evaluation (of asked items) as per tender specification.
- (iii) The price of the item should be quoted inclusive of insurance, packing, forwarding, freight (door delivery) and inclusive of GST if any. The rate should be quoted for each item both in figures and words. Only two decimal points (paise) will be taken into consideration ignoring the rest digits. In case of difference in words and figures, words will be taken into consideration for evaluation.
- (iv) The quoted rates should be final and shall not be subject to any escalation during the validity of rate contract. The bidder should submit/furnish a certificate in the tender to the effect that the price quoted by them is not more than the open market price. However, in circumstances when the price decreases during the contract period, the approved supplier should ethically intimate the same to the purchasing authority and decrease the price accordingly.
- (v) The Cover "B" of the bidder whose tender qualified technically in Cover-A will only be opened either on the same day or the next date and time will be intimated later through e-mail.

21. Rejection of the tender:

The tender paper (whole / part) will be rejected, if any of the following documents are wanting/not found with the tender bid:

- (i) Non submission of relevant documents/ samples as mentioned in Section V.
- (ii) Sealed Price bid (quoted rate) without signature and seal.
- (iii) Any pre-condition by the bidder contradicting to the tender terms & conditions or non-compliance to product specification.

Evaluation:

- (i) Tenders will be evaluated as per the requirement of the bid and the price

bid (Cover-B) shall be opened only for those bidders who will qualify in the technical bid & sample evaluation.

- (ii) The cost of the unit item including Taxes/ GST will be evaluated.
- (iii) If the approved lowest eligible supplier fails to supply items within the stipulated period of rate contract, to meet the need, the tender inviting authority reserves right to procure the same from the L2/ L3 suppliers at L1 rate, if they agree to supply at L1 approved rate or negotiated rate.

23. Performance Security:

The bidder shall have to submit performance security @ 3% of the supply order value of approved items within 7 days of issue of letter of intent (LOI) in form of Demand Draft drawn in favour of Chief District Veterinary Officer, Angul payable at Angul / Irrevocable Bank Guarantee from any Nationalised / Scheduled Bank in favour of the Chief District Veterinary Officer, Angul in the format as given in Document No.D21 with a validity period of **24 months** from the date of execution of it.

24. Notification of Award/Letter of Intent (LOI)

- (i) Within the bid validity period, the Tender Inviting Authority will notify the list of successful bidder(s) in tender before issuing the Letter of Intent (LOI).
- (ii) The successful bidder(s), upon receipt of the LOI, shall deposit the prescribed performance security within 10 (ten) days.

25. Delivery:

Supply shall be completed within 15 days from the date of issue of purchase order or as mentioned in the purchase order. Delivery shall be made at Central-store of CDVO, Angul.

26. Payment:

100% payment shall be made after submission of stock entry certificate(s) from the concerned authority and as per the availability of funds. Under no circumstances the supply should be interrupted as regards to payments.

27. Penalties:

If any product after use found to be "Not of Satisfactory Quality"/Not as per the parameter/ gives adverse reaction upon consumption", such item will be declared as "Not of Satisfactory Quality" on the basis of the report of the concerned user institutions. The said product shall be frozen. The supplier has to replace fresh stock equal to the purchased quantity and take back the frozen

stock at his own cost. In case the supplier fails to replace the stocks, the Performance Security shall be forfeited.

28. Miscellaneous Conditions:

- (i) The tender documents should be clearly written/ typed without any correction, interpolations and overwriting. Each page of the tender should be page numbered with the dated signature of the bidder. If any information or documents furnished by the bidder found to be misleading/ incorrect at any stage, their tender will be rejected.
- (ii) The approved rate and supplier will be valid for one year from the date of approval. In case of any unavoidable situation, the tender inviting authority may extend the rate contract till finalization of new rate contract for greater interest of public at large.
- (iii) MSME/SSI units will be treated as manufacturer limiting to their approved product only and eligibility conditions for manufacturer will be applicable accordingly. The relaxation will be given only to Local MSMEs registered in Odisha with the respective DICS, Khadi, Village, Cottage & Handicraft Industries, NSIC, OSIC, MSME/SSI units as below.
 - a) Exemption from submission of EMD, subject to submission of the valid registration certificates from the concerned authority and shall pay 25% of the prescribed security deposit.
 - b) Only local Micro & Small enterprises and Khadi & Village industrial units including handloom and handicrafts will enjoy a price preference of 10% over local and medium and large industries and industries outside the state.
 - c) Any local MSEs having valid ISO / ISI certification for their product will get an additional price preference of 3% as per provision of IPR-2015.
 - d) The turn over criteria is not applicable for Micro and Small Enterprises.

29. Legal disputes

All legal disputes, if any relating to purchase etc. are subject to jurisdiction in the courts of law situated at Angul, Odisha or High Court of Odisha.

30. At any point of time, the Tender Inviting Authority reserves the right to reject the tender for all items or for any one or more of the items tendered without assigning any reasons thereof.

3. The items which are light / photo / moisture sensitive should be supplied with good quality Amber coloured packing material as per IP / BP / USP/ EP grade.
4. Unit packs/ carrying packet shall be marked with the words in **CAPITAL AND BOLD LETTERS, 'FOR SUPPLY TO GOVT. OF ODISHA, NOT FOR SALE'**. MRP should not be printed. Such packing shall clearly indicate the description, quantity, name and address of manufacturer, contact No. and date of manufacture, date of expiry and Batch Number of manufacture. The medicinal item should have sufficient gap between date of supply and date of expiry (Not less than 1 year).
5. Damaged items will not be received under any circumstances.
6. Supply of drugs without the prescribed labelling will not be accepted.


