- The bidders must be a registered one. Copy of Registration certificate to be attached with the bid document.
- The bidder must have a valid GSTIN number.
- The bidder is required to submit a copy of the PAN Card along with the bid document.
- The bidder must submit copy of the IT Return for the FY 2020-21 (AY 2021-22) & 2021-22 (AY 2022-23).
- The bidders applying for the <u>Category-A</u> should submit one Demand Draft worth ₹ 10,000/(Rupees Ten Thousand) only. Again the bidder applying for <u>Category-B</u> should submit one
 Demand Draft worth ₹2,000/- (Rupees Two Thousand) only along with the bid made in
 favour of "Chief Development Officer-cum-EO, Zilla Parishad, Angul" payable in Angul from
 any scheduled commercial bank.
