The survey has been scheduled to be conducted during 2023. The bid documents can only be submitted through Regd. / Speed posts only till 27.03.2023 up to 05.00 PM. The Quotations will be opened on 28.03.2023 at 12.30 PM in the 2nd Floor conference hall of Zilla Parishd, Angul in presence of the committee members, bidders or their authorized representatives. The terms & conditions for submission of quotations are as follows.

TERMS & CONDITIONS

- The Envelope containing the quotation should be duly super scribed as "Procurement of Stationeries & Sanitary items for use by Enumerators for Survey of Social & Economical Conditions of People belonging to Backward Class in Angul District."
- The bidders are required to quote the unit price i.e. per 01 unit as specified below.
- All responsibilities regarding transportation, payment of taxes & duties, loading & unloading and all the risk factor will be borne by the supplier.
- The bidder must be registered under Income Tax (PAN), Goods & Services Tax (GST) and must have a valid GSTIN.
- The bidders must submit the IT Return Certificate for the FY 2020-21 (AY 2021-22) & 2021-22 (AY 2022-23).
- The bidder must have a minimum average turnover of ₹5.00 Lakh (Five Lakh) only in last 03 consecutive years. One certificate in this regard under the seal & signature of Registered Chartered Accountant Firm is required to be enclosed along with the bid.
- The bidders are required to submit an EMD worth Rs. 10,000/- (Rupees Ten Thousand) only in shape of a Bank Draft made in favour of "Chief Development Officer-cum-EO, Zilla Parishad, Angul" from any scheduled commercial bank payable at Angul.
