ODISHA ADARSHA VIDYALAYA SANGATHAN

Background:

Odisha Adarsha Vidyalaya Sangathan is a path breaking initiative of Govt. of Odisha to provide quality teaching in English medium at Secondary and Senior Secondary level for the children specially in semi- urban or rural areas and to give scope to rural talents who are unable to afford English medium education. Originally, a new scheme “Model Schools” was launched by Govt. of India under central assistance scheme to provide a good quality English Medium Education at par with Kendriya Vidyalaya in all Educationally Backward Blocks of the state. Subsequently, the scheme has been delinked from central assistance from the financial year 2015-16. After de-linking of the scheme, state Govt. decided to implement the scheme and establish one Odisha Adarsha Vidyalaya in each block i.e. in all 314 blocks of the state phase wise.

Basically Adarsha Vidyalayas will have infrastructure and facilities of the same standard as Kendriya Vidyalaya with stipulation on Pupil-Teacher ratio, ICT usages, holistic educational environment, appropriate curriculum and emphasis on output and outcome. The objective is to provide high quality English medium Education to the rural talents.

Key features of Odisha Adarsha Vidyalaya:

- The objective is to provide high quality English medium Education to the rural talents.
- Vidyalaya will have holistic and integral approach touching upon physical & aesthetic development in addition to academic.
- The Vidyalaya will have adequate ICT infrastructure and internet connectivity.
- There will be sufficient scope for sports and co-curricular activities.
- There is provision of Art, Music and Computer Teacher besides subject teachers..
- There is provision of well equipped laboratories and library.
- Medium of instruction is English and the Vidyalaya is affiliated to CBSE, New Delhi.
- The Vidyalayas will have appropriate pace setting activities, so that Vidyalayas in the neighborhood can benefit from it.
- The classes will be from VI to XII having two (02) sections in each class with intake capacity of 40 in each section.
- All efforts will be made to make it really a centre of excellence.

Curriculum for +2 Higher Secondary (Commerce Stream)

(A) Scholastic Areas:

1. The Commerce Stream of each school will have 80 seats
2. There will be 5 subjects in class-XI. These are
 - (i) English Core (Code 301)
 - (ii) Economics (Code 030)
 - (iii) Accountancy (Code 055)
 - (iv) Business Studies (Code 054)
 - (v) Painting (Code 049)/ Physical Education (Code 048)
3. There is no alternative subject in addition to above first 4 subjects (i.e from i to iv). All 4 subjects of class-XI will be continued to class-XII without any change.
4. Each subject carries 100 marks.
5. The students have to option only 1 subject out of subject: Painting (049) and Physical Education (048)
6. Each subject will be allotted with 8 periods per week

(B) Co-Scholastic Areas:

The Co-Scholastic activities are used as both cognitive and non-cognitive development of students can take place by exploring the child to the lesson on scholastic subjects and non-scholastic subjects. Each school has to keep following three co-scholastic subjects:-

- (i) General studies.
- (ii) Health & Physical Education.
- (iii) Work Experience.

There will be allotment of 2 periods per week to each co-scholastic area and assessment will be through grades (A1, A2, B1, B2, C1, C2, D1, D2 and E).

Admission Guidelines:

- There shall be no qualifying marks to apply for admission in Odisha Adarsha Vidyalayas in class- XI(Commerce).
- The students who have passed from OAV where class X is upgraded to class XI shall be selected first in order of their merit determined on the basis of marks secured in CBSE class-X examination.
- If seats are still found vacant, students of other Odisha Adarsha Vidyalayas of the district may be considered for admission on the basis of merit.
- If, still seats remain vacant, the admission may take place in the following order of preference
 - I. Students of the Government/ Government aided High Schools within the same block.
 - II. Students of Private High Schools within the same block
 - III. Students of Government/ Government aided High schools of other blocks of the district.
 - IV. Students of the Private/ Public High schools of other blocks of the district.

This practice shall continue till class XI is opened in all Odisha Adarsha Vidyalayas. In all cases the selection shall be on the basis of merit i.e. the marks secured in their last CBSE / BSE / ICSE Examination.

Sub: Admission of students in Class XI.

Madam/ Sir,

With reference to the subject cited above, it is to intimate that Government has been pleased to approve for opening higher secondary classes (Science Stream) at another 60 OAVs vide letter no. 11934/ Date 04.06.2022 and higher secondary classes (Commerce Stream) at 30 OAVs vide letter no.24474/ Date 16.12.2021 during academic session 2022-23.

In this regard you are intimated to take necessary steps for admission of students in Class XI. The guidelines for admission in OAVs are as follows:

1. Intake Capacity
 - (i). Science – 80 (02 Sections with 40 Students)
 - (ii). Commerce – 80 (02 Sections with 40 Students)
2. Subject Combination
 - (i). Science
Physics, Chemistry, Mathematics, Biology, English
 - (ii). Commerce
Elective Subjects – Accountancy, Business Studies, Economics, English
Optional Subjects - Painting, Physical Education (01 to be opted by student)
3. There shall be no qualifying marks to apply for admission in Odisha Adarsha Vidyalayas in Class XI.
4. A Student shall apply for admission in one stream only.
5. All notifications and circulars issued by CBSE shall be followed for subject combination in Class XI.
6. Students who have passed from the OAV including students selected for Iconic OAV where Class X is upgraded to Class XI shall be admitted in that OAV in order of merit determined on the basis of marks secured in CBSE Class – X Examination.
7. But, if any student of other OAVs of the district who has been selected for Iconic OAV, Bhubaneswar where Class XI (Science) is not opened for 2022-23 academic session, he/ she shall be given preference for admission next to admission of students of the concerned OAV selected for Iconic OAV.

8. Student selected for Iconic OAV, Bhubaneswar is eligible for taking admission in Science stream only.
 9. If seats are still found vacant, students of other OAVs of the district may be considered for admission on the basis of merit.
 10. If seats still remain vacant, the admission may take place in the following order of preference:
 - (i). Students of Government/ Government aided High schools within the same block.
 - (ii). Students of private high schools within the same block.
 - (iii). Students of Government/ Government aided high schools of other blocks of the district.
 - (iv). Students of Private high schools of other blocks of the district.
 11. Above order (as per point no. 10 above) shall continue till class XI is opened in all OAVs.
 12. In all cases selection shall be done on the basis of merit i.e. the marks secured in their last CBSE/ BSE/ ICSE examination.
 13. The Principals are requested to prepare prospectus for admission in Class XI which may be supplied to the applicants for admission.


