The proof of registration from the appropriate authority shall be enclosed along with the bid. If successful, the bidder who has not registered under State Government has to register under the State PWD in appropriate class of eligibility before signing the agreement. Bidders may submit bids for any or all the following works.

Interested bidders may obtain further information at the same address.
- 3. E.M.D. 1% to be deposited by contractor at the time of submitting bid documents then after awarded contractor has to deposit rest ISD of 1%.

N.B -E.M.D. in shape of cash /Pay orders /Bankers Cheque /Bank Draft is not Accepetable. Bidders must deposit the EMD amount mentioned in Col no 4 in shape of N.S.C/ K.V.P/ P.O.T.D/ Post Office Savings Passbook/ Deposit receipt of any schedules bank (Valid minimum one year from date of receipt) duly pledged in favour of block development officer ,Kaniha. Bids without E.M.D will be liable for rejection.

4The sale of the bid document shall start from 10 AM on dt. 20-04-2023 in the office of the Block Development Officer, Kaniha during office hour. The cost of bid document as mentioned in col. No-6 has to be paid by each bidder in shape of demand draft drawn in favour of Block Development Officer, Kaniha from any nationalized bank. Sale of bid document will be closed at 5.00 P.M on dt. 27-04-2023. Bid document will be received in the office of Block Development Officer, Kaniha through seed post or registered post only from 21-04-2023 to 28-04-2023 during office hours only. No Box/hand delivery of the Bid document will be entertained. The undersigned is not responsible for postal delay if any, in the delivery of the documentsor non-receipt of the same. The bid document may also be downloaded from website www.angul.nic.in during this period. The intending tenderers down loading the tender document has to pay the cost of tender paper for each set as mentioned in column 6 in shape of bank draft payable at SBI, Telesingha in favour of Block Development Officer, Kaniha.

- 5. Bids must be received through speed post/ Registered post having identification No.KAN-01/2023-24 shall be kept in Tender box having identification no KANB-01/2023-24 IN Kaniha block for the purpose.
- 6. The Technical bid of Bidders shall submit original affidavit regarding authenticity of their documents. along with their bids. Bids shall be accompanied with attested true copy of valid registration certificate, GSTIN and PAN card, otherwise his/her bids shall be declared as non-responsive and thus liable for rejection. The original certificates of the lowest bidder are to be produced before Block Development Officer, Kanihafor verification.
- 7. For Double cover system bidders must submit the technical bid and financial bid in different covers and both bids should put in big cover . In the top of cover bidders must write his own name and project he has applied for.
- 8. Bidders can submit one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular work will be liable for rejection.
- 9. Engineering Contractor desirous to avail the facility of exemption of E.M.D. is required to submit affidavit to the effect that he/she has not yet availed the facility for more than two works during the current financial year, failing which his/her tender will be rejected.
- 10. The bid will be opened at 10.30 A.M. on dt.29-04-2023 in the office of the undersigned, in the presence of the bidders or their authorized representatives, who wish to attend. If the office happens to be closed on the last date of sale and receipt / opening of the bids as specified, the bid will be sold and received / opened on the next working day at the same time and venue.
- 11. If the rate quoted by a bidder is less than 15% of tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimal up to two numbers will be taken for all practical purposes, without rounding off) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders/ their authorized representatives, the tender inviting authority/ his authorized representative and Accounts Officer of Block will remain present.
- 12. Additional performance security shall be obtained from the bidder when the bid amount is 5% and above and below 10% less than the estimated cost put to tender at the rate of 50% of difference between estimated cost put to tender and bid amount. In Case if the bid amount is 10% and above less than the estimated cost put to tender at the rate of 150% of difference between estimated cost put to tender and bid amount. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e estimated cost put to tender minus the quoted amount as Additional Performance Security in shape of Demand Draft/Term deposit Receipt pledged in favour of Block Development Officer within 7(seven) days otherwise the bid shall be cancelled and the security deposit be forfeited. Further proceeding for blacklisting shall be initiated against the bidder.
- 13. For building and other Construction Workers Welfare CESS @ 1% (One Percentage) of the cost of construction shall be deducted from bills.
- 14. Other details can be seen in the bidding documents.
- 15. The undersigned reserves the right to cancel/reject in partly/fully or all tenders without assigning any reasons thereof.
