**ORDER**

Pursuant to the Advertisement No.01, dated.02.08.2022 for the filling up the vacancies in different categories of Group-C posts and due to non joining of Sri Sri Alok Kumar Sethi under SC category and Sri Sambit Garnaik under ST category as per this office Order No.16 dated.16.03.2023 communicated vide Memo No.1471(4) dated.16.03.2023, **Sri Khirod Kumar Naik, S/o- Pramod Kumar Naik, At-Lia 11/12, Housing Board Colony, Chandrasekharpur, Pin-751016, Dist-Khorda** and **Sri Hensh Pradhan, S/o-Kishore Pradhan, At/P.O-Pukulingia, P.S-G-Udayagir, Dist-Kandhamal, Pin-762100** appointed as Jr. Clerk-Cum-Copyist temporarily under SC & ST category respectively in the Pay Matrix Level-04 (ORSP Rules, 2017) Rs.19,900/- 63,200/- with DA and other allowances as admissible to the State Government Employees from time to time on regular basis and **Ms. Rubi Behera, D/o-Krushna Chandra Behera, At-Qr.No.2RA 6/2, Near OMC Colony, Unit-8, Bhubaneswar** appointed as Grade-III Stenographer temporarily under UR(W) category in the Pay Matrix Level-07 (ORSP Rules, 2017) Rs.25,500/- 81,100/- with DA and other allowances as admissible to the State Government Employees from time to time on regular basis subject to the result of W.P(C) No.1273 of 2014 and W.P.(C) No. 22278 of 2017 as per the waiting list under U.R. category for the said post in accordance with the provision contained in Orissa Districts Subordinate Courts Non-Judicial Staff Services (Method of Recruitment and condition of Service) Rule, 2008 amendment Rule, 2010 with following terms and condition.

**Terms & Conditions:**

1. Your appointment is purely temporary and can be terminated at any time without assigning any reason/ cause thereof as per Rule 8(2) & (3) of Orissa District Subordinate Courts Non-Judicial Staff Services (Method of Recruitment and condition of Service) Rule 2008 and amendment Rule 2010.
2. You are to remain on probation for a period of two years from the date of your joining in service, provided that if during the period of probation, your work or conduct is found unsatisfactory or it appears that you are likely to become inefficient, the District Judge may either discharge you from service or extend the period of probation for such further period as deems fit as per Rule 8(1) of Orissa District Subordinate Courts Non-Judicial Staff Services (Method of Recruitment and condition of Service) Rule 2008 and amendment Rule 2010.
3. No TA shall be allowed for joining in the post.
4. Your appointment shall be cancelled if you fail to report joining at your place of posting on the scheduled date and time with relevant documents/ testimonials as mentioned below.
5. You are directed to report your joining in the establishment of District & Sessions Judge, Angul at **7.00 A.M.** of **08.05.2023** positively along with the following documents;
  - a. Original Educational Qualification Certificates for verification.
  - b. Medical fitness Certificate from a registered Medical Practitioner not below the rank of an Assistant Surgeon of Government Hospital in the prescribed form.
  - c. Two character Certificate from two different Gazetted Officers.
  - d. A declaration to the effect that he/ she has not more than one spouse living, if married.
  - e. An undertaking in shape of an Affidavit that the financial benefit availed on regular basis shall be realise as per the applicability of the result of WPC No. 1273 of 2014 and continuity of service subject to the result of Writ Petition in WPC No.22278 of 2017 (Sumarendra Debata and Others Vs. Government of Odisha and Others).


