ELIGIBILITY CRITERIA AND SELECTION PROCEDURE FOR CONTRACTUAL ENGAGEMENT OF ENTOMOLOGIST, NVBDCP & INSECT COLLECTOR, NVBDCP UNDER NHM, ANGUL

1. Entomologist, NVBDCP:-

Qualification:- The Candidate must have passed Post Graduate Degree in Zoology or any other branch of Bio-Science or Life Science from a recognized University/ Institution with minimum 55% marks. For Life Science candidates, Zoology should be one of the subject at Degree level.

Experience:- The candidate must have 02 years of post- qualification experience in Vector Borne Disease Control Programme under Public Health System.

Upper age limit:- Up to 40 Years.

Selection Procedure:- Application Invitation (Interview- 100 marks)

A list of eligible applicants, fulfilling the eligibility criteria shall be prepared on the basis of percentage of marks secured in final examination of the each required qualification in order of merit.

From amongst the said list of eligible applicants, 5 times of the number of vacancies from the top of merit list of each qualification as mentioned below shall be called for appearing Interview.

- Post Graduate Degree in Zoology
- Post Graduate Degree in Life Science
- Post Graduate Degree in all other remaining branch of Bio- science.

The final merit list shall be prepared as per the marks secured by the candidates in the Interview.

The candidates securing 50% and more marks in Interview shall be kept in the Final Panel Merit list with the validity of 01 year from the date of its approval.

DOCUMENTS TO BE SUBMITTED WITH THE APPLICATION:

1. Completely filled up application form as available in the District website i.e www.angul.nic.in.
2. Two recent self-attested passport size color photographs have to be submitted to the application and one to be affixed at the desired space earmarked on the application form.
3. Self-attested Photocopies of all **Mark sheet, Testimonials and Certificate** from Matriculation onwards as per the requirement of the post must be attached with the Application.
4. Self-attested Photocopies of valid Residence Certificate (The residence certificate should not be older than 06 months from the date of advertisement.)
5. Self-attested Photocopies of Identity proof documents like Voter ID Card, ADHAR Card, PAN Card, Driving License or Passport must be attached with the Application, otherwise the application will be rejected

N.B:- Besides the above, the following Provisions also shall be applicable for the above post.

1. Age Relaxation and Additional Weightage of Marks applicable for the eligible applicants who are employees of the OSH & FW Society:-

a. To avail the benefit of age relaxation and weightage , employees concerned should have completed at least **Three terms** of Contractual service (11 months each) under the OSH & FW Society.

b. The remarks recorded in PAR of the employee concerned **must be "Outstanding" or "Very Good"** for the preceding 03 (Three) terms of contractual services under the OSH & FW Society.

c. The **Age relaxation** for the applied post in respect of the employees of the OSH & FW Society shall be allowed **@ 1 year for each contractual term of service** in the Society up to a maximum of 10 years, over and above the maximum age limit prescribed in the Advertisement for the said post, subject to an age ceiling of 55 years.

d. Candidates who is an employee of the OSH & FW Society and has cleared all the steps in the recruitment process up to the final level of selection shall be eligible for award of grace marks to the extent of 01 percentage of the total marks of examinations for each completed term of services in the society up to a maximum of 10 percentage of the total marks which shall be added to the total marks secured by the said employee.

e. All the above provisions shall also be applicable for only one member of the family of a deceased employee of the OSH & FW Society, if eligible, as would have been applicable to the employee concerned.

2. Consideration of weightage in case of securing equal marks by the Candidates:-

- If two or more candidate's secure equal marks, then the final merit list shall be prepared on the basis of their date of birth as per 10th certificate i.e. elder candidate shall be kept above the younger one in the final merit list.

- The total marks shall be up to 03 (three) digits format, for example- 45.567%

3. The candidates securing 50% and more marks in Final Panel Merit list shall be kept in the Panel with the validity of 01 year from the date of its approval to fill up future vacancies. If any.
