QUOTATION/ TENDER CALL NOTICE

Quotations in sealed envelopes are hereby invited from the interested travel agencies/tour operators/ pvt. individuals with GST registration for providing one no. of AC petrol driven vehicle having sitting capacity not more than 5 including driver for one year, which shall confer to the terms & conditions (Annexure-A) for official use in The District Industries Centre, Angul on monthly rent basis. The period of hiring of vehicle may be extended basing on the performance of the driver and the condition of the vehicle.

1. The Service provider shall have a valid OGST registration to participate in the tendering.
2. The Vehicle must be in road worthy condition, shall not be more than three years old from the date of initial registration and must have valid registration certificate, insurance certificate, fitness certificate, pollution certificate, valid contract carriage permit, proof of up to date tax payment etc mandatory for plying of vehicle. (The supporting documents must be enclosed with the tender papers).
3. The driver of the vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport/ passenger vehicle. (The supporting documents must be enclosed).
4. The driver should be well behaved, gentle and obedient in nature.
5. As sum of Rs. 5,000/- (Rupees Five Thousand) only shall be deposited by the intending bidders in shape of account pay bank draft drawn in favour of the General Manager, DIC, Angul payable at Angul and submitted along of the tender as security deposit. After completion of the tender process, the amount will be refunded to unsuccessful bidders.
6. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants).
7. The vehicle must achieve a fuel efficiency of 17 KM/L.
8. The details of the make & year of manufacture of vehicle, registration no., mileage (KM covered per liter) and name of the driver, driving license no., and period of validity should be specifically provided in the general bid information to be furnished with the quotation/tender (Annexure-B).
9. The quotation complete in all respect should reach the undersigned on or before 15.11.23 by 02:00 PM and shall be opened on the same day at 04:00 PM in the presence of the bidders or their authorized representatives.

10. The application form of quotation/ tender containing general bid information and terms & conditions for hiring of vehicles etc. will be available with DIC, Angul during the office hours on payment of a non-refundable amount of Rs. 1000/- (Rupees One Thousand) only from 31.10.23 to 14.11.23 or can be downloaded from the district govt. website www.angul.nic.in from 31.10.23 to 14.11.23. In case the application form is downloaded from district website, the applicant shall furnish a demand draft in favour of General Manager, DIC, Angul payable at Angul for an amount of Rs. 1000/- (Rupees One Thousand) only towards the cost of application along with application, which would be non-refundable.

Annexure-A

Terms & Conditions

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as valid Registration Certificate, Insurance Certificate, Pollution Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up-to-date tax payment etc. and D.L. of the driver available all the times.

2. The Department / Office hiring the vehicle shall not be responsible for any damage/ loss caused to hired vehicles or loss of life / injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.

3. The hire charges to be paid for monthly basis is final but does not include cost of fuel, which is to be paid separately basing on actual consumption and as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes, Battery etc. will be borne by the bidder.

4. It shall be the responsibility of the bidder to provide a good driver and the remuneration of the driver shall be borne by the owner.

5. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.

6. In case of the vehicle do not report regularly, the authority will be at liberty to terminate the agreement without prior notice.

7. The vehicles shall report for duty for minimum of 25 days in a month.

8. In case of emergency, the driver will have to report for duty as per the requirement. No extra payment shall be demanded.


9. Monthly hire charges and reimbursements towards cost of fuel (as per actual) and lubricants (as per Govt. norms) of selected bidder will be paid in every succeeding month, as per as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.

10. The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract.

11. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.

12. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.

13. If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
