TERMS AND CONDITIONS **RENTALOF** OF TENDER FOR LEASE ON 4(FOUR)NOS.OF ROOMS IN THE PREMISES OF AMA BUS STANDS, PALLAHARA VIDE TENDER NOTICE NO.4157 DT13.12.2022

- 1. Allotment of 04 nos. of shop rooms in the premises of AMA BUS STAND PALLAHARA as mentioned in the aforesaid tender notice will be licensed to individual person/Body/Corporate/company for a period as mentioned Annexure-A
- 2. The complete sealed tender as per proforma enclosed shall be dropped in the Tender Box kept in the Section Officer Room of Block Office, Pallahara or by Registered/Speed Post so as to reach the Office on or before 28.12.2023 upto 1.00 P.M. after which no tender will be received and the sealed tenders will be opened on 28.12.2023 at 3.00p.m. The undersigned shall not be held responsible for any postal delay.
- 3. Envelope of the sealed tender must be superscribed "Tender for license of rooms in the premises of Ama Bus stands with Room Number".
- 4. The full amount of EMD in shape of Bank Draft to be submitted as per tender schedule (Column 6 of Annexure-A) at the time of submission of tender paper failing which the tender paper shall be treated as cancelled.
- 5. An agreement shall be executed in the manner as prescribed by the undersigned reserving the right of Panchayat Samiti Office to alter/amend the condition of agreement at any time without assigning any reason thereof.
  - 6. G.S.T. as applicable will be levied on such monthly rent to be paid by such allottee.
  - 7. Monthly rent shall be enhanced by 20% in every three years.
  - 8. No tender form will be considered unless it is accompanied with cash receipt/bank draft against payment of earnest money as indicated above.
  - 9. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
- 10. In case of default in payment of monthly rent by 7th of every succeeding month, interest @ 18% shall be charged.

- 11. That, in the event of default in pay1ncnt of monthly rent for more than two months, it shall be realized from the security amount deposited by the licensee and that will be recouped by the licensee in the next month, otherwise the license shall be cancelled.
- 12. After finalization of tender, allotment order will be issued in favour of successful tenderer within one month from the date of finalization of tender to take over the physical possession of the room as applied for.
- 13. The interested tenderer can apply specific room number with offer price of rent per month in the application form while participating in the tender, otherwise the tender shall be treated as void.
- 14. In case more than one tender are applied for a specific room with similar rate the committee can go for a lottery in presence of all committee member and tenderers or their representatives and will be decided after outcoming of the result of the lottery.
- 15. The allotment of room in the premises of AMA BUS STAND Categorically shall be only for three years. It may be extended beyond three years if necessary after satisfaction of abiding terms and conditions of tender Rule.
- 16. In case Bus stand is decided to be developed for any other purpose, the allottee has to vacate the area on receipt of one month Notice from OSRTC as the area is purely earmarked for temporary bus stand and OSRTC will take over responsibility.
- 17. If any temporary construction noticed, the same will be demolished by the authority without making any correspondence or intimation. No representation will be entertained to that affect.
- 18. The security amount and EMD amount deposited by the successful tenderer bears no interest and under no circumstances the tenderer shall claim the interest.

- 19. The successful tenderer shall execute an agreement within 7(seven)days from date of intimation.
- 20. The allottee shall not use the room in the premises of OSRTC Bus Stand at under the control of Unit-in-Charge, OSRTC, concerned for any purpose other than the purpose as mentioned in the tender notice and no illegal activities shall be carried out there.
- 21 The licensee shall install the power and water connection, if any, as per requirement at the site of the allotted room in the premises of OSRTC Bus Stands at his/her own cost and shall pay the necessary charges to the concerned authority regularly. Panchayat Samiti Office, Pallahara shall not take any responsibility in this regard. Failure to deposit these charges in time shall lead to cancellation of lease.
- 22. Dumping of wastage/garbage without cleaning the same daily and causing unhygienic situation shall entail cancellation of the lease without giving prior intimation along with forfeiture of the security deposit. The licensee shall make his/her own arrangement for shifting of the organic and other waste daily. He/she shall keep the area neat and clean.
- 23. The security deposit and EMD amount shall be refunded to the unsuccessful bidders after completion of tender process.
- 24. The sale of alcohol and other contraband and dangerous goods/materials in any form is strictly prohibited in the shop. Further smoking and consumption of alcohol intoxicants in the premises are strictly prohibited.
- 25. No child labour shall be employed by the licensee in any case. Full detail of the employee person will be maintained by the allottee. shop holder and will be provided competent authority and when demanded.
- 26. The allottee/shop owners shall be responsible for the repair of shop required, if any during license period with the permission of competent authority.

Block Development Office:

- 27. Any illegal issue or dispute arising out of the activities of the licensee shall be the sole responsibility of the licensee Panchayat Samiti Pallahara shall not be held responsible to that effect If allegation is proved, the license will be cancelled.
  - 28. Details of terms and conditions will be stipulated in the agreement to be signed by both the parties and the same is enforceable by law.
  - 29. The licensee shall not sub-let the allotted shop to any other person.
  - 30.If the successful tenderer is a firm/institution/company, it must be registered under the respective Act which in force by the State/Central Government. In case of person, the Aadhaar and PAN is mandatory.
  - 31. After execution of agreement, if the successful tenderer fails to take physical possession of allotted room the EMD will be forfeited and rent due till the date of cancellation will be realized from security deposit.
  - 32. All the disputes to be raised during license period by the licensee are under jurisdiction of the Court of Pallahara
