#### **ELIGIBILITY CRITERIA: (SELF ATTESTED DOCUMENTS REQUIRED TO BE SUBMITTED)**

1. The bidder must be a registered Firm/ Partnership firm/Sole Proprietorship firm.
2. The bidder must have valid GST registration certificate.
3. The bidder must have a valid PAN.
4. The bidder must have a local office in state of Odisha. Proof of address must be attached.
5. The bidder should have a average minimum turnover of Rs. 50 Lakh in last three years (i.e. FY 20-21, FY 21-22, FY 22-23). The bidder must submit annual turnover certificate of last three financial year (FY 20-21, FY 21-22, FY 22-23) duly certified by C.A (Annexure – II).
