If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.

- 09. Bidders are to submit only the original BoQ uploaded by Publisher after entering the relevant fields without any alteration / deletion / modification Multiple BoQ submission shall lead to cancellation of bid.
 - 10. As it is a percentage rate tender, the bidder quoting zero value is valid and will be taken as schedule of rates.
