- 02. Quantity: Approximately 01,20,000.00 Cards (08 pages par card having both side printing)
- 03. Place, Date and Time of receiving the tender:-Tender shall be received at DEO-cum-DPC, SS, Angul through Speed Post/Registered Post only on or before Dt 08/02/2024 by 2 PM.
- 04. The cost of Tender document is **Rs.2000.00** [Two thousand] non-refundable. No relaxation to any one for cost of tender paper.
- 05. The interested Printers are advised to submit sealed envelope super scripting "Tender for Printing & Supply of Holistic Progress Card" to DEO-cum-DPC, SS, Angul".
- 06. The Earnest Money Deposit (EMD) of **Rs.30,000**/- (Rupees Thirty thousand) only, refundable (without interest), should be necessarily accompanied with the Tender Paper in the form of Demand Draft in favour of "DPC, RTE-SSA Angul Tribal (General)" payable at Angul.
- 07. The successful bidder will have to deposit a performance security deposit of @ 5% of the Total Tender Value of the Contract.
- 08. Opening of Tender: The Tender shall be opened at Office of the DEO-cum-DPC, SS, Angul on 09/02/2024 at 3 PM in presence of bidder or their authorized representative and the District Procurement Committee. In case of any unavoidable circumstances if the tender could not be opened on the schedule date, and then a date will be fixed as per decision of the authority.
- 09. **Eligibility**: Bidder/Firms must be registered at DIC/NSIC/MSME having Production Certificate with Four-colour Machine having sheet fed, valid PAN, GST clearance certificate
- 10. Date and Place of delivery: Delivery of Holistic Progress Card Report card shall be made at 08 no's Block Point of Angul District within 15 days from the



date of issue of work order and obtained the dated signature in token of receipts, failing which the security amount mentioned in the work order will be forfeited and action as deemed proper will be taken.

- 11. **Pocketing and supply**: Rate of printing should include stitching folding and packeting. Holistic Progress card must be packed school-wise and block-wise for delivery at 08 Block point. No Transportation Charges will be allowed separately.
- 12. **Single Contract**: -The Intending firm should have three years experience for Printing & Supply of Printing works, worth of Rs.20.00 lakhs or above to any District of Odisha
- 13 **Paper sample**: The sample paper duly signed and stamped should be attached with the tender application form.
- 14. All entries in the tender form should be legible and filled clearly. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached. No overwriting or cutting is permitted in the Tender Paper. In case of any deficiency, the tender shall be summarily rejected and conditional bid documents will not accepted.
- 15. The authority reserves the right to cancel all or any part of tender or withdraw or relax any of the terms and conditions mentioned above without assigning any reason thereof.
