



- A. The tender process will be of two bid system-Technical Bid and Financial bid process. The tenderer should submit two separate sealed covers mentioning Technical Bid & Financial Bid. The tenderers who qualifies in Technical Bid only will be eligible to participate in Financial Bid.
- B. The Bid Must Contain the Requisite Tender Document Cost of Rs.1000/- and EMD of Rs. 50,000/- as per the advised mode in the technical bid. The Bid documents can be obtained from the office of the undersigned on payment of requisite fee or can be downloaded from website [www.odishaforest.in](http://www.odishaforest.in)/[www.deogarh.nic.in](http://www.deogarh.nic.in) from 11:00 Hours of 24.02.2024 to 10:00 Hours of 04.03.2024 at 10:00 Hours for bidding.
